Our multipurpose room provides instructional space for an additional instrumental music class and 3rd grade music. Walking through our school, one can see that all areas are utilized for a variety of small groups and large group instruction. As part of our commitment to a safe and orderly campus, we have developed a comprehensive Student Discipline Plan. ON TRACK, providing both consequences and rewards. An Emergency Disaster Plan has been developed and provides alternatives for a variety of potential disasters. Evacuation drills are conducted regularly throughout the year. Our disaster preparedness plan is up-dated yearly and is on file in the office. We maintain emergency supplies such as dried food, water, first aid, tarps, space blankets, and other essential disaster supplies in a central location.
