South Lake opened as a new facility in September 1994. The school was designed with the library media center as its hub. Surrounding it are six wings, each of which each have four classrooms opening onto a technology workroom/presentation area with a sophisticated infrastructure. There are three full classroom size computer labs within the schools, plus three additional mini-labs located within the library and other wings of the school. The facility was planned to maximize cross-curricular instruction, collaboration of

professionals, and personalization of students. South Lake is a learning center where students feel safe and secure. A campus safety supervisor supports and enhances school security and safety. The custodial staff takes pride in supporting and maintaining South Lake's facility. Students regularly assist in the cleaning and tidiness of their school.
