12. SUPERINTENDENT'S REPORT

Minutes:

Superintendent Walker expressed his hopes everyone had a safe and restful winter break. He

announced the California Distinguished Schools program, which was suspended during the pandemic, has identified elementary and alternative schools for 2023; Irvine Unified School District was recognized with six of the 38 Orange County schools named. Those schools are: Brywood, IUSD Virtual Academy, Santiago Hills, Stonegate Elementary Schools, Vista Verde School, and San Joaquin Middle and High Schools. The Annual Survey is open for stakeholder input until January 27th. The feedback is critical to help the District guide investments of resources, which impacts District personnel and programs. Schools use the information to identify annual needs and actions; it's an important part of the District's decision-making process. In closing, he reported, the District's COVID-19 Dashboard is trending down, which reflects staff and parent diligence in focusing on health and safety. The Orange County Health Care Agency urges that anyone with symptoms should not come to work or school, even if they test negative for COVID-19 and he thanked everyone for their continued vigilance.
