8. SPECIAL PRESENTATIONS / RECOGNITIONS

a. IUSD Special Education: Spotlight on Student Access

Minutes:

Melanie Hertig, Executive Director of Special Education, commenced the presentation of the Special Education Department's spotlight on student access and exceptional staff commitment, by introducing Karena Gibbs, Amy Ochoa, Lezlee Kerbrat, and Desiree Shafer, who provided an overview on four student access programs throughout the district.

Karena Gibbs, Adult Transition Coordinator, presented the Irvine Adult Transition Program (IATP), which serves students aged 18-22, who live in Irvine and leave high school with a certificate of completion and continue to demonstrate the need for transition services, including working on independence skills. She introduced some of the students who were in the audience, who work at the Able Coffee Roasters Coffee Cart. At IATP, they work on each student's Individual Transition Plan (ITP) which includes independent living skills, employment, and education/training. She also shared the Safety Education and Life Skills (SEALS) program, a collaboration with the Irvine Police Department (IPD). Officer Aragon, provides lessons to the students, in collaboration with the teachers, for the students to become comfortable with community helpers and first responders in the community. In closing, she shared the recently started IATP Instagram account which is popular with the students and further depicts the work happening from day to day at IATP.

Amy Ochoa, Behavior Dept. Coordinator, presented the California Autism Professional Training and Information Network (CAPTAIN) grant work project, which uses implementation science frameworks to build capacity and increase fidelity of implementation of evidenced-based practices for students on the autism spectrum. The focus is to build the capacity of regional teams to support the implementation of evidence-based practices (EBPs) through effective training, coaching, and leadership,

for students on the spectrum within our school district. The grant is a state-wide, multi-year implementation plan with a focus on improving the quality of services for students with autism. In the 2021-22 school year, the groundwork was laid for the implementation plan rollout in 2022-23, including identification of transformation zones, which will serve as demonstration sites. IUSD leads the county in identifying the transformation zones, which are classrooms that will be developed into demonstration sites over the next few years, starting at the elementary level with the hopes of scaling up over the next few years.

Lezlee Kerbrat, Team Leader supporting the Assistive Technology Dept., presented the Open Access grant project, which is funded by the California Dept. of Education and the California Collaborative for Educational Excellence, designed to support fostering regional teams who will lead ongoing capacity building initiatives in the area of training, coaching, and community support. IUSD's focus has been in the area of Assistive Technology (AT) and Alternative Augmentative Communication (AAC). IUSD is building capacity through professional learning opportunities, resources, and coaching in the creation of accessible curriculum for students, building tiered support for AAC, creating a community of practice, and empowering school teams, students, and families through a collaborative approach.

Desiree Shaffer, Portola High School Education Specialist, presented information regarding the Irvine Unified Sports program, which is a program through the Special Olympics, who's vision is to be recognized globally as an iconic program that promotes and creates social inclusion between individuals with and without intellectual disabilities through sport. The benefits of Unified Sports include whole school inclusion, creating memories and long-lasting friendships, opportunities for physical activity, promoting school spirit and camaraderie, and raising awareness of varying abilities on campus. She highlighted the 2021-22 Unified Sports events, including a Portola High School track meet for which students helped each other in preparing to compete.

Board members thanked the presenters for spotlighting various Special Education programs throughout the district.

Debra Kamm spoke to the topic.

In 2019-20, the District coordinated regional after-school Mandarin programs; however, the pandemic challenged those efforts. The District is once again looking for ways to support the interest in the community and continue to explore the option of a Mandarin immersion program; however, we aren't able to make any commitments at this point, but are evaluating a program for the 2023 school year and will be providing

updates to the Board. Regarding the concerns in the community regarding the Irvine International Academy charter school, the District does not have any oversight over that program, other than the legal requirement to provide facilities. Anyone with concerns regarding that charter school should contact the Orange County Department of Education.
