#### 12. SUPERINTENDENT'S REPORT

Minutes:

Superintendent Walker reported on his attendance at the Irving High School football game and of the 200 National Merit Scholarship semifinalist titles in Orange County, 88 IUSD students were named. Woodbridge High School was the only high school in Orange County to be named a National Blue-Ribbon school; Principal Krebs, the Woodbridge staff and students should be very proud. He extended his appreciation to the Irvine Unified Council PTA and to Dr. Bayne, IUSD's Risk Manager, for providing a safety overview including information about IUSD's partnership with IPD at the PTA's presidents' meeting. The Parent Center near the Jeffrey Trail Middle School campus is now open and will aid in empowering parents and guardians with resources and trainings to support students. Mental health and wellness continues to be a top priority and was the topic of the last Education Advisory Committee meeting. He reported on his attendance at the CHOC awards, which recognized the Tsao Foundation, who supported the addition of WellSpaces at IUSD secondary schools. The districtwide professional development day just took place with customized trainings to meet the needs of the sites and is going to be available on-demand for future use. He invited the community to IUSD's State of the District on October 18, and in closing, he noted the CDPH recently issued an alert around Fentanyl, which is being disguised as other drugs. Last year, the Board passed a Board Policy to allow Narcan on all secondary school campuses, and staff will be bringing an update to that policy to expand the availability of the life-saving drug to all school sites.
