This addendum forms a part of the contract and modifies the original bid documents. It is intended that all work affected by the following modifications shall conform to related provisions and general conditions of the contract, of the original bid documents. **Modify the following items wherever appearing in any portion of the bid documents**. Acknowledge receipt of Addendum No. 1 in the space provided on this form as well as on the bid form. Failure to do may subject bidder to disqualification.

The following revision and/or additions are hereby made:

I. Revised Bid Form (**Submit with bid**):

Correction made to the ADA Cashier Stand Cabinet dimensions (attached is the revised bid form and specifications for this unit).

- II. Response to Request of Information (RFI's). (*District response in bold blue italic*)
 - Q. Is prevailing wage required for install?
 - A. No. Vendor will not be responsible for installation, equipment purchased through this bid will be Owner Furnish Contractor Installed (related to construction projects) or Owner Furnished Owner Installed.
 - Q. Will performance or payment bonds be required?
 - A. No.
 - Q. On Page 15, Item 15: Could you please define "any required installation"? Do you want us to assemble and set in place? Or are we making final utility connections. This mainly pertains to the cooking equipment. Obviously there is a huge page grade difference for a plumber [gas connections] vs an assembler.
 - A. Vendor will be responsible for delivering fully assembled equipment, set-in place and final utility connections (if requested). Reference the District response for the first question.
 - Q. When you call out the actual school, are you planning to place the order for all the equipment listed for that school on the same P.O., for delivery on the same day? And will you be placing the orders for all the schools listed on the same day? Or different schools on different days throughout what period of time?

Addendum No. 1

A. Yes, the purchase orders will be issued by the school sites identified in this bid and delivery of equipment will be required on the same day, starting with Westpark E.S. Vendor will be required to work closely with the Facilities Construction Supervisor. This order will be placed upon board approval and award of contract(s).

Remaining school sites listed on this bid, the purchase orders will be placed at a later date to be determined.

The awarded contract(s) will be effective from board approval date through June 30, 2019, as indicated in the bid documents.

- Q. On Page 27, "Various Sites" is it your intention to place one P.O. for all the equipment on that page, for delivery on the same day? And will we need to deliver to the various sites or to a central warehouse? For example, you have listed 30 ea GA Systems items. Could you potentially cut 30 different PO's for delivery on 30 different days to 30 different locations?
- A. The intent of this bid (all items) is to be used District wide, equipment will be ordered upon request and will be delivered directly to the school site.
- Q. Also on page 27, it says to reference attachment for complete specs. So are you referring to the spec sheets you attached? For instance on item 1 [convection oven] the spec sheet you attached does not call any accessories, like casters etc.
- A. The descriptions noted under the "Various Sites" items (page 27), are identified correctly.

ALL OTHER PROVISIONS of the Bid Documents shall remain unchanged. This Addendum is hereby made a part of the Bid Documents to the same extent as those provisions contained in the original documents and all itemized listings thereof.

Top is 16 gauge 304 stainless steel #4 finish bound with (4) 10/32 stainless steel screws flush at each end. No exposed screws on the front or back of cabinet. Front and back edges turned down 102 degrees for sleek aesthetics. Corners at precisely 90 degrees for flush alignment to other cabinets. One locking pin to adjoin other G.A. Systems units.

Body of cabinet is 20 gauge galvanized trimmed with 20 gauge stainless steel back and end panels. Tubular 1-1/2" square stainless steel tubing frames the cabinet's structure to join the front, back and end panels. Top frame is 1" square cold rolled tubing, bottom frame constructed from 1" square stainless steel tubing.

Front, back and ends trimmed with 22 gauge stainless steel #4 finish trim to accept interchangeable color panels. All NSF approved high pressure laminates are available as well as stainless steel or powder coated finish.
