10. Submission of the National Foundation for the Improvement of Education Grant Proposals, 1994

Approved the submission of the 1994 National Foundation for the Improvement of Education Grant Proposal, under the provisions of the Student Success Grants. This proposal is designed to provide middle school teachers with training in STAR Lifeskills curriculum so that teachers teach students assertion skills.

University High School Office Hours Status Report

David Brown provided an update on the steps taken to implement the new office hours schedule at University High School. A more detailed report will be provided during the April 19 Board meeting, including and updated student survey, and an evaluation of the impact of new procedures on student attendance.

Board Appointment to the Safe Community Task Force

On the motion of Member Burnham, seconded by Member Wakeham and carried, Mary Ellen Hadley was appointed to represent the Board of Education on the Safe Community Task Force.

California Learning Assessment System (CLAS)

A written report was included with the agenda and is on file in the District Office.

David Brown provided a video presentation and information on CLAS, a performance-based assessment tool which will provide a more direct connection between instruction and assessment. Brown expressed the need to have patience with the implementation of this new assessment tool which will ultimately provide a more in-depth picture of what children know and are able to do.

ORAL COMMUNICATION

Paul Harvey, 16 Red Rock, shared his appreciation for Joslynne Blasdel's work with the WHS band, tall flag and drill team. Harvey also requested consideration and exploration of developing a local field competition which could serve both as a fund raiser and a community event.

CLOSED SESSION

The Board adjourned to Closed Session at 8:25 p.m., to discuss three student discipline issues and two personnel items (Approval of Settlement Agreement and Reassignment of Administrators). The following actions were taken:

Student Discipline Issues

On the motion of Member Wakeham, seconded by Member Burnham and carried, the Board agreed to expel a student (No. 460252) for the remainder of the 1993-94 school year, for violating the previously suspended expulsion.

On the motion of Member Burnham, seconded by Member Wakeham and carried, the Board expelled a student (No. 920343) for the remainder of the 1993-94 school year, and immediately suspended the expulsion, placing the student under strict probationary conditions.

On the motion of Member Burnham, seconded by Member Wakeham and carried, the Board expelled a student (No. 893292) for the remainder of the 1993-94 school year.

Personnel Items

On the motion of Member Wakeham, seconded by Member Burnham and carried, the Board approved the Settlement Agreement between an employee (No. 13-4740) and the Irvine Unified School District, as outlined by the Deputy Superintendent of Personnel.
