# Irvine Unified School District Irvine, California Board of Education Minutes of Regular Meeting March 6, 2001

## Study Session: Future Development

Irvine Company representatives Mike LeBlanc, Ken Coulter and Roger McErlane presented plans for future development in the northern sphere planning areas. They reviewed various issues including anticipated student growth based on planned housing, location of future school sites, and the establishment of Community Facilities Districts to fund the projects. The Board discussed the need for consideration of infrastructure projects and suggested the development of a decision-making timeline.

## **Legislative Priorities 2001**

# Californian's for Power Reliability (CPR)

Member McInerney provided background on the formation of the Californian's For Power Reliability group, formed in response to the energy crisis by the South Orange County Regional Chambers of Commerce.

On the motion of Member McInerney, seconded by Member Wakeham and carried, 5-0 (Student Members Busch, Crockett, Kim and Shafer voting "Yes"), the Board endorsed the White Paper entitled "Solution-Based Outcomes Requested by California Power Consumers - February 2, 2001" and authorized staff to add the Irvine Unified School District to the list of Californians for Power Reliability.

**Grant Proposal: Project Success - The Irvine Tolerance Education Program** (removed from Consent Calendar for discussion)

Member Choi remarked on the timeliness of this grant based on recent incidents such as the Santana H.S. tragedy. Nancy Colocino, Guidance Resources, provided an overview of the project and reiterated the need to increase sensitivity to hate/violence issues. Board members discussed expanding the program to all high schools and commended the Guidance and Project Success staff for the excellent programs already in place. Student Board Members discussed the need to maintain open communication lines between adults and students and the importance of parent involvement.

On the motion of Member Choi, seconded by Member Wakeham and carried 5-0, (Student Members Busch, Crockett, Kim and Shafer voting "Yes"), the Board approved the submission of the Project Success: The Irvine Tolerance Education Program grant proposal to the California Department of Education FY 2001-02, for the purpose of creating a comprehensive tolerance education program.
