Financial Crisis Update

Marc Winthrop, IUSD legal counsel, provided an update on the proposed settlement agreement with the County. Winthrop outlined concerns about the "good as gold notes," saying they are more in the realm of pledge of best efforts notes, and said the final wording of the agreement is still undergoing revisions. It is hoped that the agreement will be finalized by the end of the week, and if it proves acceptable to all impacted parties, the cash portion could be available by mid-May.

Paul Reed added his update that the District is seeking release of pre-petition dollars to carry IUSD through the month of April in meeting all obligations. Reed was confident that this process would go smoothly.

Additionally, staff was directed to establish contact with the City of Irvine and the Irvine Ranch Water District to discuss loan possibilities.

Appointment of Member(s) to the Foundations for the Future Board

A written report was included with the agenda and is on file in the District Office.

Members Adler and Burnham have volunteered to serve as Foundations Board members, so that the Foundations for the Future Board can conduct necessary business.. The Board further agreed that no fund rasing would take place until October.
