Special Presentation

The Coastline ROP Educational Role in the Irvine Schools

Paul Snyder, Superintendent of the Coastline ROP (Regional Occupational Program) provided an overview of their continuous improvement efforts and commitment to assisting all students with career pathways. The Coastline ROP has moved away from being a "vocational" training program, to promoting career options that are regional, and have relevancy and rigor. Snyder asked that all IUSD students be encouraged to take advantage of the unique career opportunities offered through the Coastline ROP.

PTA Volunteer Recognition

Sherry Slunka introduced the Presidents of each school's PTA and shared their significant contribution of love and time. Slunka, with those presidents present for the meeting, presented the Board with the parents' gift of 282,309 hours for the 1995-96 school year, saying that this investment of time and dedication was a representation of the parent-school partnership that benefits the students of the Irvine community. In addition, Slunka extended congratulations to College Park for being selected the District PTA's Outstanding Unit and Program. In closing, Slunka presented the "Unsung Hero" Award to Heather Bell for her tireless community service and mentorship of booster volunteers.

Announcements and Acknowledgments

Member Wakeham thanked the Irvine Exchange Club for a "stupendous" Excellence in Teaching Banquet. Wakeham specifically acknowledged the work of Tom Wall, and thanked staff members Steve Garretson, Leah Laule, and Stan Steele for their part in making the event a tremendous success and tribute to teachers.

Wakeham also expressed appreciation to The Irvine Company for the 1996 Spectrum Awards. The accomplishments of the outstanding students from each of the participating districts, including the six award recipients from IUSD, were remarkable and deserving of special recognition.

Member Burnham thanked the Irvine Children's Fund for their sponsorship of another successful year with the Irvine Junior Games. Burnham said that approximately \$80,000 was raised, and will support the Irvine Child Care Project. Burnham closed by saying the Junior Games was a great community event.

President Hadley thanked Member Wakeham for her role in the planning of the Excellence in Teaching Banquet and echoed the sentiment that this year's celebration was wonderful for all who participated.

Hadley also thanked Member Burnham for his time and leadership with the Irvine Child Care Project Board.

Superintendent's Report

Dennis Smith congratulated Nancy Colocino and her staff for obtaining a \$400,000, three year grant for the Healthy Start Proposal for SELF High School.

Smith also provided information on the Governor's most recent proposal pertaining to education, saying that while much needs to be done in terms of the legislative process, the earmarking of funds for reduction in class size, reading materials, books for school libraries, and money towards safety needs, shows the governor is attempting to tackle a much needed agenda.

In closing, Smith discussed the strategic planning survey process. He explained that The Irvine Company, which had funded the survey, added questions to the end of the instrument, intended as a community assessment of Irvine's schools, without the knowledge of the Board or IUSD staff. The Irvine Company staff apologized for their mistake and removed the questions immediately, upon expressions of concerns from the District. Given that the "trailer" questions were concerning community politics, they understood that the questions left the wrong impression with the community. Because the questions were at the very end of the survey, however, Smith expressed confidence that the information to be gleaned from the survey will still be valid for school district purposes, and the survey data will belong exclusively to the Irvine Unified School District.

Springbrook Planning Process

A written report was included with the agenda and is on file in the District Office.

Dean Waldfogel highlighted the Springbrook planning process, explaining that the Springbrook staff had designed the process in a highly responsive manner to parent concerns. Dennis Gibbs provided a chronology of the steps leading to committee work on school action plans. Waldfogel and Gibbs shared that in an open process, the school community has identified the strengths and areas for possible improvement. The Principal and the School Site Council, in conjunction with PTA representatives have taken responsibility for designing plans to address the priority issues: basic skills, student discipline, and test scores. The School Site Council has scheduled June 6 as the date for presenting a comprehensive action plan to the Springbrook school community.

The Board provided input including requests for the final report to include measurable goals, the utilization of expertise from around the district, continued discussions on the philosophical differences that may exist, and the maintaining of an effective parent/school partnership.

Hiring Practices - Recruitment of Teachers

A written report was included with the agenda and is on file in the District Office.

Sue Long presented a report on the district's hiring practices and recruitment of teachers. The challenges and successes in trying to attract qualified minority candidates was also discussed. Long shared that while progress has been made, the progress is slow in light of the smaller percentage of minority students pursuing careers in education and having many options for employment. Long also shared that the district is pursuing the option of hiring star college graduates early, and providing contracts in advance of knowing specific placement. This process has the potential to attract the best and the brightest candidates, while increasing diversity.

The Board accepted the report and encouraged continued efforts in recruiting minority teachers.

Comprehensive Test of Basic Skills

A written report was included with the agenda and is on file in the District Office.

Beverly Huff provided a presentation on the district-wide CTBS results, providing national comparisons. Overall, in examining the CTBS percentile rankings for the past three years, the IUSD trend is to have increasingly higher rankings over time, with a high percentage of the students scoring at or above the national average, and a high percentage of students with scores that are comparable to the nation's top performing students.

In answer to the question regarding any schools showing declining trends, Dean Waldfogel explained that in such cases, the school staff, along with district staff, work to determine the cause and design plans to remedy whatever factors may be contributing to a declining trend.

After the Board's discussion, Member Adler requested that the Board receive information in writing on the action plans designed to assist those schools demonstrating declining trends.

Dress Code/Uniform Policy

A written report was included with the agenda and is on file in the District Office.

After second reading and discussion, on the motion of Member Burnham, seconded by Member Regele and carried, the Board adopted the Dress Code/Uniform Policy and accompanying administrative regulations.
