The Board discussed various implications of the proposed options, including programmatic issues, cost factors, and the Board's commitment to balancing the needs of both regular and special education students.

On the motion of Member Wakeham, seconded by Member Regele and carried (Member Choi voting "No"), the Board authorized relocation of up to two special education preschool classes (specific classes to be determined by staff) from Los Naranjos for the 1999-2000 school year to other locations in the district (to be determined based on space availability and appropriate facilities), and requested appointment of a special education preschool representative to the Facilities Master Plan Committee.

The Board further directed staff to continue to monitor and evaluate actual enrollment from the Oak Creek community, pursue interim release of the Tustin Base property as a possible permanent location for the program, and communicate progress to the Board and community.
