

# 15. d. Amend Contract/Award – Technology Equipment and Peripherals 🔗



# Rationale

On December 17, 2019, the Board of Education awarded Bid No. 19/20-01 IT Technology Equipment and Peripherals to CDW Government, LLC (CDWG). Bid No. 19/20-01 IT Technology Equipment and Peripherals was a unit-cost bid that included equipment and services the Irvine Unified School District (District) anticipated were necessary to meet the District's technology needs.

The initial term of the contract was January 1, 2020 through December 31, 2021 with the option to extend for three (3) additional one (1) year terms, for a maximum term of five (5) years, in accordance with provisions contained in Education Code section 17596. Certain products specified in the bid have subsequently been updated, altered or discontinued, therefore, the parties wish to amend the underlying Bid Form Pricing Sheet to allow the District to purchase 1) new, upgraded products that replace those originally specified, and 2) substitute products which are direct replacements for original products that have been discontinued. Section 19.C of Bid No. 19/20-01 IT Technology Equipment and Peripherals allows the successful bidder to "delete Equipment removed from the market by the manufacturer or and/or add Equipment introduced to the market by the manufacturer under the following conditions: a. Deleted Equipment has been discontinued and are no longer available from the manufacturer; b. Added Equipment is a direct replacement for original Equipment listed in the bid, Contractor's bid, the resulting Agreement and/or any Purchase Agreements."

Manufacturers have discontinued certain products specified in the bid. In some cases, the replacement products include significant technical upgrades that have affected the product price. Additionally, some manufacturer cost increases require an adjustment to licensing and product costs. The Technical Specifications and Requirements form in Bid No. 19/20-01 IT Technology Equipment and Peripherals allows "price increases reflecting original manufacturer's cost increases to the successful Bidder."



### **AMENDMENT TO AGREEMENT**

This AMENDMENT TO AGREEMENT ("Amendment") by and between CDW Government LLC ("CDWG", "Consultant", or "Provider") and IRVINE UNIFIED SCHOOL DISTRICT on behalf of itself and its affiliated schools ("Customer" or "IUSD"), is entered into on January 1, 2021 (the "Effective Date"), with reference to the facts set forth below. Provider and IUSD agree to amend the terms and conditions of the Agreement awarded pursuant to Bid No. 19/20-01 IT Technology Equipment and Peripherals ("Agreement"), upon and subject to the terms and conditions of this Amendment, notwithstanding anything to the contrary in the Agreement. Initial capitalized terms not otherwise defined herein shall have the meaning set forth in the Agreement and Bid documents.

### RECITALS

- a. Provider and IUSD entered into the Agreement on January 1, 2020 with a term date ending December 31, 2021; and
- b. Provider and IUSD have mutually agreed to amend the Agreement as set forth in this Amendment.

# **AGREEMENT**

NOW THEREFORE, in consideration of the mutual covenants, promises, representations, warranties, and conditions set forth herein, Provider and IUSD hereby agree as follows:

- 1. Whereas, section 19.C. of Bid No. 19/20-01 IT Technology Equipment and Peripherals allows the successful Bidder to "delete Equipment removed from the market by the manufacturer or and/or add Equipment introduced to the market by the manufacturer under the following conditions: a. Deleted Equipment has been discontinued and are no longer available from the manufacturer; b. Added equipment is a direct replacement for original Equipment listed in the bid, Contractor's bid, the resulting Agreement and/or any Purchase Agreements." Such changes have been made by manufacturers and the Bid Form Pricing Sheet is hereby amended to reflect changes in Exhibit A.
- 2. Whereas, The Technical Specifications and Requirements form in Bid No. 19/20-01 IT Technology Equipment and Peripherals allows "price increases reflecting original manufacturer's cost increases to the successful Bidder. Documentation may be required to prove price increase from the manufacturer to the successful Bidder." Such price increases have been made by manufacturers and the Bid Form Pricing Sheet is hereby amended to reflect changes in Exhibit A. Manufacturer documentation is attached hereto in Exhibit B.
- 3. the event that the price of an item decreases, such lower price is to be immediately extended to Irvine Unified School District. In addition, within 24 hours of any price decrease, the District shall be notified in writing of such changes and pending orders shall reflect the newer price.
- 4. Except as otherwise expressly modified herein, all terms and conditions of the Agreement and bid documents shall remain in full force and effect. To the extent there is a conflict between this Amendment and the Agreement, this Amendment shall control.
- 5. This Amendment may be executed in multiple counterparts, each of which shall be deemed an original and, together shall constitute one document.

IN WITNESS WHEREOF, Provider and IUSD have executed this Amendment to Agreement as of the Effective Date.

In January 2020, Google <u>announced</u> they would be increasing the MSRP of Chrome Education Upgrade from \$30 USD to \$38 USD per device license. 


