Regular Meeting November 21, 1995

CALL TO ORDER

The Regular Meeting of the Board of Education was called to order by President Burnham at 6:05 p.m. in the District Administration Center, 5050 Barranca Parkway, Irvine, CA.

RECONVENE REGULAR MEETING

President Burnham reconvened the Regular Meeting at 7:30 p.m. and reported on Closed Session discussion and then read the following statement:

On November 17, 1995 the District received a letter from the Pacific Regional Office of the Securities Exchange Commission in Los Angeles stating that the staff of that office intends to recommend to the Comission that it institute a civil proceeding against the District. The staff's letter further provides the District with the opportunity to respond to the staff's recommendations by a written submission (a "Well's Submission") which will be forwarded to the Commission along with the staff's recommendations. No civil proceeding or action has been initiated by the Commission against the District.

The District is obtaining legal representation and will cooperate with the SEC and its staff in this matter. Further appropriate public announcements will be made as events unfold. Subject to the advice of legal counsel, however, Board Members and District Officials are not able to provide further comment at this time. District Superintendent Dennis Smith has been designated as the official District spokesperson.
