

## Addendum No. 1

### Bid No. 25/26-02NS, Kitchen Equipment

October 8, 2025

Addendum No. 1 forms a part of the Agreement and modifies the original bid documents. It is intended that all work affected by the following modifications shall conform to related provisions and general conditions of the Agreement, of the original bid documents. ALL OTHER PROVISIONS of the original bid documents shall remain unchanged. **Modify the following items wherever appearing in any portion of the bid documents. Acknowledge receipt of Addendum No. 1 on the Bid Form. Failure to do so may subject bidder to disqualification.**

#### Changes to Bid Documents

- 1.1 A correction has been made to the year of the “Bid Deadline” date on the cover page of the bid packet, see attached page below.

#### Response to Contractors’ Questions

- 1.2 Question: *“On page 19 of the bid, it highlights Oliver Packaging, but only lists “All Non-Specified Items” “\_\_\_\_\_ % Catalog Discount”. Does that mean we only submit our Product Catalog with the type of discount that would be available to Irvine USD? There does not appear to be a specific line item for us to bid on. Such as one of our Tray Sealers.”*

Answer: For a couple of manufacturers listed, the District decided not to specify particular equipment, rather ask for a percentage discount for all equipment for that particular manufacturer.

- 1.3 Question: *“After looking at the bid form pricing sheet, the manufactures listed that state, “all models”, do you want us to quote you all available models within that category of equipment?”*

Answer: The bidder should provide a catalog percentage discount for what is listed; for example, “shelving – all models,” bidder should provide a percentage discount for shelving or “freezer cabinet – all models,” bidder should provide a percentage discount for freezer cabinets.

- 1.4 Question: *“Additionally, the manufactures that state, “Other non-specified items”, what would you like us to quote for that?”*

Answer: Bidder should provide a percentage discount for all other non-specified items, meaning, a percentage discount for everything else the manufacturer provides.

- 1.5 Question: *“We have been notified to quote out item 30 for RATIONAL on the bid documents. Can you please confirm what model(s) to quote along with the details.”*

Answer: Answer: There is no specific model and item to quote, bidder should be providing the manufacturer catalog discount they can pass onto the District; bidder is responsible for reviewing the bid in its entirety and determining whether they can provide catalog discounts as outlined.

1.6 Question: *"What is the overall length of the machine requested you need please?"*

Answer: The District does not know which machine this question pertains to.

1.7 Question: *"Is the length of the machine the same as your current machine from the beginning of the infeed to the end of the discharge conveyor?"*

Answer: The District does not know which machine this question pertains to.

1.8 Question: *"What is the overall length, from the beginning of the infeed to the end of the discharge conveyor, that you are requesting?"*

Answer: The District does not know which machine this question pertains to.

1.9 Question: *"Will you also want roll up infeed side tables? [PG Machinery Roll Up Infeed Side Tables Flyer Rev.1 \(4.1.25\)](#)."*

Answer: Reference Answer to 1.3.

1.10 Question: *"Will you want the Lazy Susans with or without side tables attached? [PG Machinery Accessories Flyer \(1.10.25\)](#) "*

Answer: Reference Answer to 1.3.

1.11 Question: *"What diameter Lazy Susan is requested? 39" or 48"?"*

Answer: Reference Answer to 1.3.

1.12 Question: *"What are the terms of sale? Can you provide a deposit?"*

Answer: It is the bidder's responsibility to review the bid in its entirety for the terms and conditions of the bid.

1.13 Question: *"On Item 28, when you list "Vertical Form Fill and Seal Machine", do you want an infeed and a discharge conveyor? The machine is not operable without these [VB Bagger with Infeed Conveyor](#). The new bagger is slightly higher in profile so the current infeed will not work but the discharge will."*

1.14 Question: *"Are you interested in a thermal coder for the machine? This will allow you to print a date and or product type / name on the bag [Date Coding and Thermal Printing | Platinum School Nutrition](#). Print can be 2.5" standard or up to 4" in width."*
