Rationale

The initial term of the contract is through June 30, 2023 with the option to extend for two (2) additional one (1) year terms upon mutual written agreement between the District and Vendor and the approval of the District's Governing Board, for a maximum term of three (3) years, in accordance with provisions contained in Education Code section 17596.

The District has been pleased with the services provided by the vendors; therefore, Facilities staff requests the authorization to extend the first one (1) year term with no change to pricing, as allowable per the terms and conditions outlined in the contract, from July 1, 2023 through June 30, 2024.
