# AUDIOLOGIST

### **DEFINITION:**

Under general supervision, serves as a member of the Individual Education Program Planning Team and provides referral, assessment, IFSP or IEP and itinerant services to students' birth to 22 in a variety of educational settings.

ESSENTIAL DUTIES AND RESPONSIBILITIES include the following. Other duties may be assigned

- Assess hearing abilities of students; provide otoscopic examination and tympanometry to evaluate hearing and monitor continuous use of hearing aids.
- Complete CAPD Assessments.
- Interpret and report results of assessment and testing, including those conducted by various professionals within the schools and community.
- Develop treatment plans and make appropriate recommendations and referrals based upon assessment results.
- Provide assistance in solving amplification and equipment needs and assist with the acoustic treatment of the classroom.
- Participate in the development of Individualized Education Plans (IEP).
- Review reports, and IEP goals and objectives and assist special education staff in coordinating appropriate curricular resources to ensure that objectives are met in an organized manner.
- Work with students, parents, and other staff members to coordinate instructional programs between home and school.
- Consult with administrators, staff, parents, and students in modifying regular education programs for students receiving the majority of their instruction in the regular classroom setting.

## QUALIFICATIONS

#### Knowledge of:

Principles, theories, methods, techniques, and strategies pertaining to teaching and instruction of secondary level students; academic, social, and behavioral characteristics of secondary level students; educational curriculum and instructional goals and objectives, and educational trends and research findings pertaining to comprehensive secondary programming; motivational, behavior management and behavior shaping strategies, techniques and methods, and conflict resolution procedures; socio-economic and cultural backgrounds of the school population.

#### Ability to:

Plan, organize, develop, and conduct a comprehensive teaching and instructional program for students at the secondary level; provide appropriate and effective learning experiences for students from a wide range of socio-economic levels and cultural backgrounds; effectively assess the instructional and educational needs of students, and design, develop, and implement sound instructional and educational programs; provide a motivating and stimulating learning environment; perform research and development activities pertaining to curriculum and instructional programs and innovative and creative pilot projects designed to enhance student educational opportunities and experiences; comply with the District's core values, continuous improvement efforts and strategic initiatives.

#### **Credential:**

Valid California Credential authorizing service in grade levels and areas assigned.

#### **Training and Experience:**

A combination of student teaching, internship, or teaching experience.

#### **Education:**

Bachelor's degree or higher including all courses to meet credential requirements.

#### PHYSICAL DEMANDS

While performing the duties of this job, the employee is regularly required to stand; walk; use hands to finger, handle, or feel objects, tools, or controls; reach with hands and arms; talk or hear; and taste or smell.
