

18. a. Amend Contract/Award - Technology Equipment and Peripherals @

Rationale

The Irvine Unified School District (District) has a need for technology equipment and peripherals.

On August 27, 2024, the Board of Education (Board) awarded Bid No. 23/24-01 IT Technology Equipment and Peripherals to CDW Government, LLC (CDWG). Bid No. 23/24-01 IT Technology Equipment and Peripherals was a unit-cost bid that included equipment and services the District anticipated were necessary to meet the District's technology needs.

The initial term of the contract was January 1, 2025 through December 31, 2029.

Certain products specified in the bid have subsequently been updated, altered or discontinued, therefore, the parties wish to amend the underlying Bid Form Pricing Sheet to allow the District to purchase 1) new, upgraded products that replace those originally specified, and 2) substitute products which are direct replacements for original products that have been discontinued. Section 19.C of Bid No. 19/20-01 IT Technology Equipment and Peripherals allows the successful bidder to "delete Equipment removed from the market by the manufacturer and/or add Equipment introduced to the market by the manufacturer under the following conditions: a. Deleted Equipment has been discontinued and is no longer available from the manufacturer; b. Added Equipment is a direct replacement for original Equipment listed in the bid, Contractor's bid, the resulting Agreement and/or any Purchase Agreements."

Manufacturers have discontinued certain products specified in the bid. In some cases, the replacement products include significant technical upgrades that have affected the product price. Additionally, some manufacturer cost increases require an adjustment to licensing and product costs. The Technical Specifications and Requirements form in Bid No. 23/24-01 IT Technology Equipment and Peripherals allows "price increases reflecting original manufacturer's cost increases to the successful Bidder."

AMENDMENT TO AGREEMENT

This Amendment to Agreement ("Amendment") by and between CDW Government LLC ("CDWG", "Consultant", or "Provider") and Irvine Unified School District on behalf of itself and its affiliated schools ("Customer" or "District"), is entered into on August 27, 2025 (the "Effective Date"), with reference to the facts set forth below. Provider and District agree to amend the terms and conditions of the Agreement awarded pursuant to Bid No. 23/24-01 IT Technology Equipment and Peripherals ("Agreement"), upon and subject to the terms and conditions of this Amendment, notwithstanding anything to the contrary in the Agreement. Initial capitalized terms not otherwise defined herein shall have the meaning set forth in the Agreement and Bid documents.

RECITALS

- a. Provider and District entered into the Agreement on January 1, 2025 with a term date ending December 31, 2029; and
- b. Provider and District have mutually agreed to amend the Agreement as set forth in this Amendment.

AGREEMENT

NOW THEREFORE, in consideration of the mutual covenants, promises, representations, warranties, and conditions set forth herein, Provider and District hereby agree as follows:

- 1. Whereas, section 19.C. of Bid No. 23/24-01 IT Technology Equipment and Peripherals allows the successful Bidder to "delete Equipment removed from the market by the manufacturer or and/or add Equipment introduced to the market by the manufacturer under the following conditions: a. Deleted Equipment has been discontinued and are no longer available from the manufacturer; b. Added equipment is a direct replacement for original Equipment listed in the bid, Contractor's bid, the resulting Agreement and/or any Purchase Agreements." Such changes have been made by manufacturers and the Bid Form Pricing Sheet is hereby amended to reflect changes in Exhibit A.
- 2. Whereas, section 11 of the General Conditions of Bid No. 23/24-01 IT Technology Equipment and Peripherals allows the successful Bidder to notify the District "of any changes in MSRP" and the Technical Specifications and Requirements form in Bid No. 23/24-01 IT Technology Equipment and Peripherals allows "price increases reflecting original manufacturer's cost increases to the successful Bidder. Documentation may be required to prove price increase from the manufacturer to the successful Bidder." Such price increases have been made by manufacturers and the Bid Form Pricing Sheet is hereby amended to reflect changes in Exhibit A. Manufacturer documentation is attached hereto in Exhibit B.
- 3. Pursuant to section 11 of the General Conditions of Bid No. 23/24-01 IT Technology Equipment and Peripherals, in the event that the price of an item decreases, such lower price is to be immediately extended to District. In addition, within 24 hours of any price

- decrease, the District shall be notified in writing of such changes and pending orders shall reflect the newer price.
- 4. Except as otherwise expressly modified herein, all terms and conditions of the Agreement and bid documents shall remain in full force and effect. To the extent there is a conflict between this Amendment and the Agreement, this Amendment shall control.
- 5. This Amendment may be executed in multiple counterparts, each of which shall be deemed an original and, together shall constitute one document.

IN WITNESS WHEREOF, Provider and District have executed this Amendment to Agreement as of the Effective Date.

This message is a follow-up to our communication from April 10, 2025, regarding the upcoming price adjustments previously scheduled for July 1, 2025, in response to the evolving tariff landscape.

After further review, Epson has determined that certain price modifications will need to take effect earlier than initially planned. Effective June 1st, you can expect to see adjustments averaging between 10% and 12% across many of our product categories. On July 1st, pricing for Commercial Projection will increase within the same range.

These upcoming adjustments reflect only a portion of the tariff-related costs and do not fully offset the overall impact. We want to be transparent that, depending on how conditions evolve, further pricing adjustments may be required.

The following details on order management are to ensure a smooth transition for our partners.

Order Management

- To ensure the equitable allocation of product, orders received that exceed your current run rate by more the 10% will need to be revised or cancelled.
- Current pricing will be honored for standard orders placed which have received credit approval and are in shipping status from our warehouse as follows:
 - o On or before May 31, 2025 for products impacted by the June 1st change
 - o On or before June 30, 2025 for the July 1st change
- Open Orders, which are defined as a backorder (no product allocated to the order, no credit approval) as well as orders with a future ship date beyond those noted above, will be repriced automatically and put on hold until you confirm acceptance of the updated pricing.
 - You may either cancel your current orders and replace them with orders at the updated pricing OR
 - Email your Account Manager or Customer Account Service representative with your approval/acceptance of the new pricing.

Special Order Circumstances

 Some Commercial Product Categories including POS System Device Solution orders placed on or before May 31, 2025, with and Epson confirmed ship date by June 30, 2025, will be honored at current pricing.

Please refer to the section above on Open Order Repricing.
