Based on current and projected enrollment, it is anticipated that Portola High School will grow beyond its current capacity. The Irvine Unified School District (IUSD) will be placing six (6) interim relocatable classroom buildings in 2025 to achieve the necessary capacity.

In compliance with IUSD Board of Education Policy and Administrative Regulation – 7110.1 on the placement of structures on existing school sites, we are notifying you of IUSD’s intent to expand the existing facility at Portola High School. The proposed general location for the expansion is shown on Exhibit A (reverse side of this notice).

All interested persons are invited to participate in the Public Information Meeting, which will provide information on the proposed project.
