

COORDINATOR IV: MATHEMATICS

DEFINITION:

Under the general direction of the Director of Science Technology, Engineering and Math (S.T.E.M.), provide support for implementation of CA Standards and Frameworks for TK-12, oversee professional learning, and assist in development, implementation and evaluation of curriculum and instruction in mathematics and content area literacy TK-12.

ESSENTIAL DUTIES AND RESPONSIBILITIES include the following. Other duties may be assigned.

- Demonstrate an understanding of and support implementation of CA standards and frameworks for TK-12
- Assist in the development, implementation, and evaluation of curriculum and the instruction in mathematics and content area literacy TK-12
- Assist in the collection, interpretation, and use of data and assessment results to improve instructional practice and student learning
- Coordinate mathematics and content area literacy instruction across all school sites
- Coordinate mathematics instructional materials adoption
- Coordinate mathematics and content area literacy professional learning and support materials in collaboration with the Director of S.T.E.M. and Director of Professional Learning
- Facilitate and model effective collaborative communication to support professional learning communities
- Evaluate and supervise department Teachers on Special Assignment (TOSA)
- Attend district meetings as needed
- Serve as a mathematics liaison to our schools and parent community

Five years of successful certificated teaching experience.
