Technology in IUSD

Welcome to IUSD! Each IUSD employee is issued a unique username and password. This will get you access to technology resources, including the substitute/absence reporting system, district email, district computers, secure district websites, and wireless on IUSD campuses.

It is through the IUSD email system that employees will receive important communications such as future Reasonable Assurance letters and TB test renewal notices. We encourage all IUSD employees, including substitutes, to check their IUSD email on a regular basis.

Setting up your Username/Password

Your technology account will be setup within two business days of HR completing the hiring process.

Step 1: Change your password at https://identity.iusd.org before you will be able to use technology resources.

- Use a laptop/desktop (not a mobile phone) to complete this step.
- Your initial username and password will be:

Username: Your first and last "preferred" name provided to HR (e.g.

johnsmith)

Password: The ten-digit primary phone number you provided to HR

Step 2: Access your email from any computer:

• Go to http://mail.iusd.org

• Username: Your full name, followed by @iusd.org (e.g., *johnsmith@iusd.org*)

• Password: Same as above.

Absence Reporting and Substitute Assignment System

IUSD uses the **Frontline Absence Management** system for employees to record absences and assign substitutes when necessary. Substitutes use the same system to accept jobs.

- 1. Go to <u>frontline.iusd.org</u>.
- 2. Sign in with Organization SSO
- 3. Enter your IUSD email address, (e.g., johnsmith@iusd.org)
- 4. Use the same password you use to log on to your IUSD email and computers as your password.

Contact information updates may be submitted online through the IUSD Staff Portal. Our IUSD intranet provides employee information such as guidelines, calendars, wellness information and more.

Access to Websites

The Children's Internet Protection Act (CIPA) requires school districts to filter website content that may be considered "obscene or harmful." However, IUSD recognizes that many sites that may contain questionable content, also host valuable educational resources. Therefore, IUSD employees who take an online course may have access to bypass the filter to access additional content, including popular video and social media sites.
