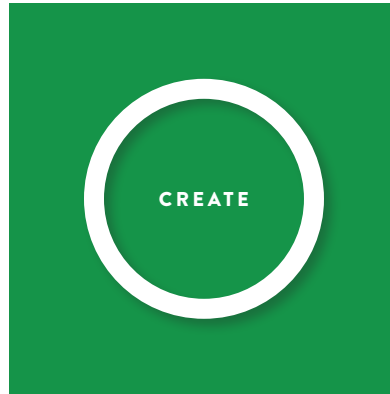
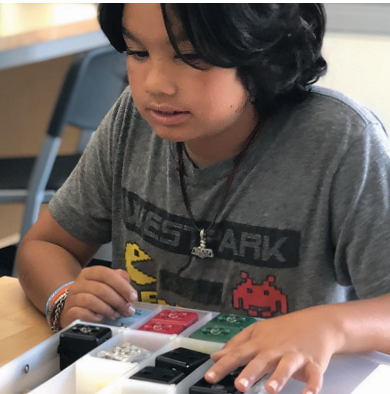

FROM THE SUPERINTENDENT

DEAR NEIGHBOR, SINCE VOTERS PASSED MEASURE E SIX YEARS AGO, THE IRVINE UNIFIED SCHOOL DISTRICT (IUSD) HAS COMPLETED OR BEGUN CONSTRUCTION ON ALL 28 OF THE SCHOOLS SLATED FOR IMPROVE-

MENTS. IN PARTNERSHIP WITH EACH SCHOOL COMMUNITY, IUSD HAS THOROUGHLY PLANNED AND EFFICIENTLY IMPLEMENTED MEASURE E PROJECTS TO ENSURE STUDENTS AND SCHOOLS RECEIVE UPGRADES IN A TIMELY MANNER.

ABOUT MEASURE E

Measure E, a locally controlled funding source, was passed by voters in June 2016 and provides IUSD with a maximum available bond issuance of \$319 million. The bond issuances occur in multiple funding series over 12 years and provide funding for facilities improvements to 28 of the District's 40 schools.

YOUR DOLLARS AT WORK

Bringing all schools up to a similar standard not only supports educational equity for all students but it protects the outstanding quality of education for which IUSD schools are known, helping to keep home values strong across the district. Measure E projects are focused on facility and technology infrastructure modernization; upgrades to classrooms, science labs and high school theaters; the creation of collaborative learning spaces; the development of innovation labs; enhanced accessibility; and other upgrades to improve safety, comfort and the learning environment for students.

CITIZENS OVERSIGHT COMMITTEE

BOARD APPOINTED COMMITTEE

In accordance with California state law, for measures passed with 55 percent of the vote, the Irvine Unified School District Board of Education first appointed a Citizens Oversight Committee (COC) during the September 13, 2016 Board Meeting. The COC's role is to monitor bond expenditures and ensure bond revenues are allocated in compliance with the voter approved Measure E. The focus of the committee is to provide transparency and maintain public confidence in the use of Measure E bond funds. COMMITTEE REQUIREMENTS

Applicants must commit to a two-year term of service and reside or own property within the School Facilities Improvement District (SFID) boundaries. See the back cover to view the SFID boundary map. Membership is voluntary, without compensation, and members must be at least 18 years of age. Employees, vendors, contractors, consultants, or IUSD officials are not eligible for appointment to the Committee.

The Education Code requires a minimum of seven (7) members representing the following categories:

- **One (1)** member who is a parent or guardian of a child enrolled in the District within the boundaries of the SFID
- **One (1)** member who is both a parent or guardian of a child enrolled in the District within the boundaries of the SFID and active in a parent-teacher organization, such as the PTA or school site council
- **One (1)** member who is active in a business organization representing the business community residing in the District within the boundaries of the SFID
- **One (1)** member who is active in a senior citizens organization residing in the District within the boundaries of the SFID
- **One (1)** member who is active in a bona-fide taxpayers association residing in the District within the boundaries of the SFID
- **Two (2)** members of the community at-large residing in the District within the boundaries of the SFID

ANNUAL AUDIT

In February 2021, the COC issued its fourth annual audit. The COC concluded:

Based upon the listed activities, the Committee advises the public that the District is in compliance with Article XIII A, Section 1(b)(3) of the California Constitution: Bond proceeds have been expended on projects set forth in the ballot measure; No bond proceeds have been used for teacher or administrative salaries or other school operating expenditures; and audits have been performed as prescribed by law.

COMMITMENT TO EDUCATIONAL EQUITY

THE IRVINE UNIFIED SCHOOL DISTRICT'S (IUSD) IMPLEMENTATION OF MEASURE E PROJECTS TO UPGRADE OLDER CAMPUSES HAS BEEN UNDERWAY FOR THE LAST FIVE YEARS, TO ENSURE STUDENTS HAVE ACCESS TO THE SAME INSTRUCTIONAL TECHNOLOGY AND LEARNING TOOLS, NO MATTER WHERE THEY ATTEND SCHOOL. TO DATE, THE DISTRICT HAS COMPLETED OR BEGUN UPGRADES AT EACH OF THE 28 SCHOOLS WITHIN THE SCHOOLS FACILITIES IMPROVEMENT DISTRICT (SEE MAP ON BACK COVER).

The district staff has been intentional and efficient in ensuring that these dollars impact students in a timely manner. We want students in our older schools to have access to the same educational features and opportunities as students in our newer schools, so we can have educational equity for all students.

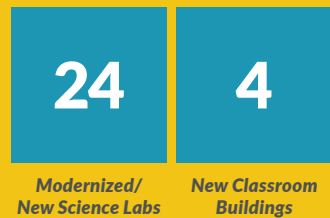

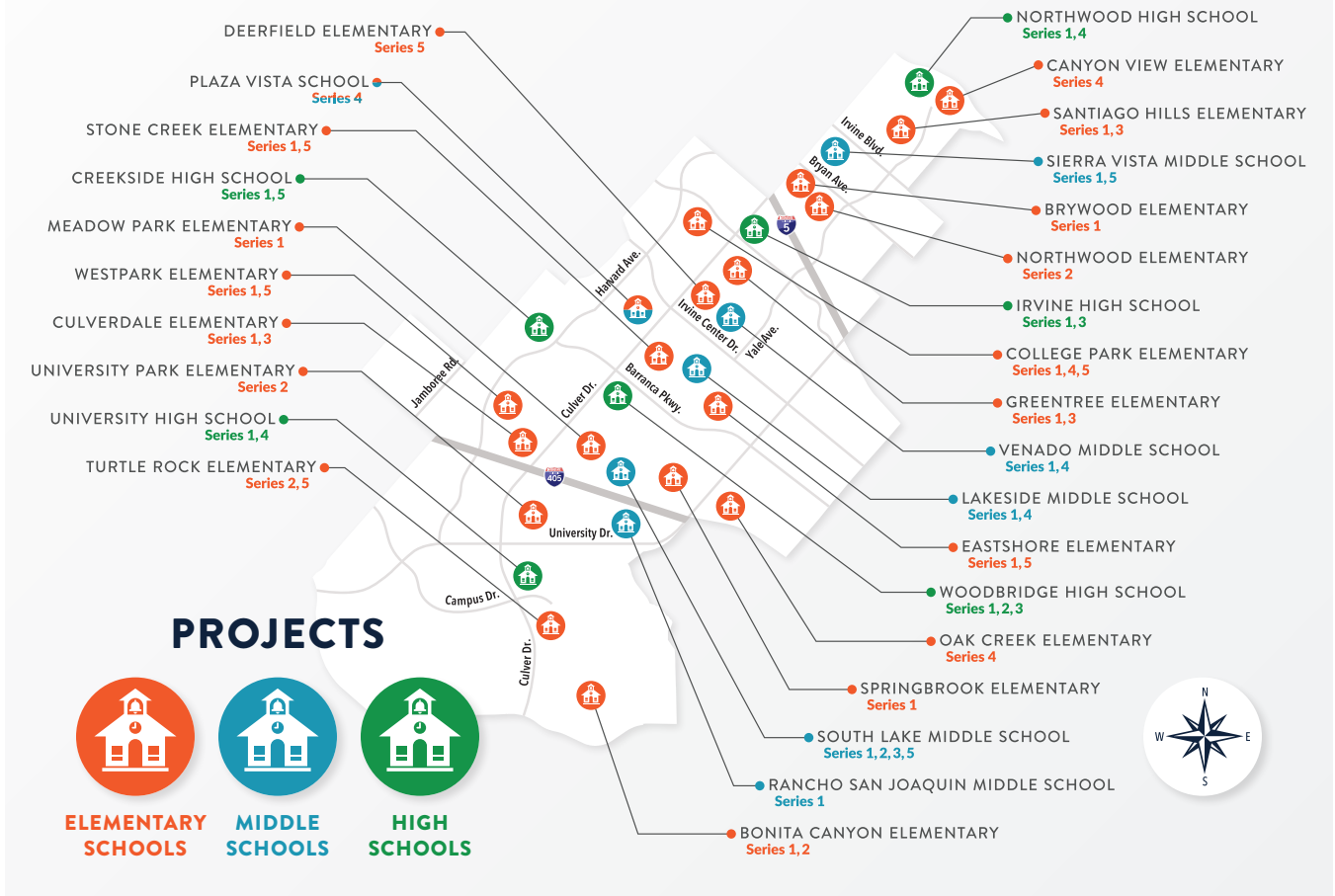
