Minutes:

Heather Phillips, Director of Literacy, and Rob Vicario, Coordinator of Social Science and Content Literacy, presented the K-8 History-Social Science Instructional Materials Selection Process presentation. Heather reviewed the adoption timeline, which started with the review of the new History-Social Science Framework and the formation of the IUSD K-8 HSS Steering Committee in the summer of 2017-18. The adoption committee consisted of 67 teachers representing 24 school sites consisting of representatives from every grade level kindergarten through eighth grade. Rob pointed out that the new instructional materials are consistent with the current content standards but incorporate the 2016 California History-Social Science (HSS) framework. Prior to this adoption, the previous K-8 HSS adoption was in 2005. The committee reviewed their top interests and identified commonalities to help create their criteria for evaluating instructional materials. Additionally, the group utilized the 2018 HSS Adoption Toolkit provided by the California County Superintendents Education Services Associates.

The state approved instructional materials were made available at the OCDE Publisher Fair and at the IUSD exhibit that was open after school for two weeks. In addition, the Literacy team hosted an IUSD Publisher Fair where the K-8 HSS Adoption Committee representatives had an opportunity to listen to publisher representative presentations, ask questions, and examine instructional materials. The committee used a forced ranking method to identify the top two publisher materials for each grade span K-1, 2-5 and 6-8. In the 2018-19 school year, entire grade level teams piloted each publisher's textbook as their core instructional material for a period of 6-8 weeks per publisher. Training was provided to the piloting teachers over the summer for Pilot Phase 1 and during the school year for Pilot Phase 2, with real time support available during the pilot. The teachers, students and parents were surveyed after each textbook pilot to gain their feedback. In addition, there were presentations to principals and a Parent Information Night for parents to review the proposed textbooks.

In determining which instructional materials to recommend, the committee reviewed the stakeholder input as well as how the digital integration was handled and the response and resolution time provided by the publisher. After reviewing all of the data the recommendation is to adopt HSS Instructional Materials for grade spans K-1 by Studies Weekly, 2-5 by Pearson and 6-8 by McGraw Hill. With the approved adoption the textbooks can be ordered in time for training to occur over the summer in time for both year-round and traditional schools.

Board members asked about the timing of available instructional materials for review and consideration, and asked what happens to the current textbooks in use. Heather and Rob communicated that all state approved textbooks were available in physical and/or digital format for review and consideration noting all available textbooks received initial feedback to help determine which textbooks to pilot. Additionally, the current textbooks will be collected as they are not in compliance with the new History-Social Science Framework and Content Standards; however, teachers use a variety of supplemental materials or additional resources and will be able to maintain a class set of the current textbook to use as a learning resource with the understanding that these textbooks are not to be used for core instruction.

The Board thanked the Literacy team for their thorough process and efforts.

Minutes:

John Fogarty, Assistant Superintendent of Business Services, presented the Second Interim Report which is the District's second official revision to the final adopted budget and includes actual financial data through January 31, 2019.

He reviewed the Governor's 2019-20 proposed state budget which includes full funding of the Local Control Funding Formula (LCFF) and funding of the projected statutory Cost-of-Living Adjustment (COLA) at 3.46%. The proposed budget does not include one-time discretionary funds as in years past. Governor Newsom's budget includes funding priorities outside of the LCFF including allocation of \$2.8 billion to CalSTRS to reduce pension liability and district contributions; \$576 million to support additional services for districts with high concentrations of disadvantaged student populations, which IUSD isn't likely to qualify for; an allocation of \$1.6 billion to support universal preschool, full day kindergarten and child care programs; and \$1.5 billion for Proposition 51 state facility bonds to be sold.

The proposed 3.46% COLA is anticipated to have an impact of \$10.8 million to IUSD with an additional \$8.1 million in LCFF funding from projected growth; however, noting IUSD's projected growth may be less than expected which would reduce the LCFF funding amount as it is based on enrollment for a total projected LCFF increase of \$18.9 million. After step and column, special education growth and STRS/PERS increases, which all school districts anticipate, IUSD also accounts for the expense of new schools or growth leaving an unallocated amount of \$8 million.

John reviewed the STRS and PERS projected increases noting a slight reduction based

on the proposed one-time buy down by the Governor. The reduction in STRS and PERS payments could equal to \$50 per ADA or \$1.7 million annually to IUSD.

Board members Glasky and Brooks employed the use of producing a resolution in support of the use of one-time funds to reduce the STRS and PERS contributions when deemed necessary or appropriate.

In closing, he reviewed the General Fund Unrestricted balance noting it was tracking as planned and presented the positive second interim certification. John cautioned that while the economy continues to grow there are signs that a slowdown may be on the horizon. A recent OC Register article reported a 13.3% county wide decline in real estate from 2017 to 2018.
