Superintendent Walker presented the artwork of the Young Masters Art Event Cover Artist Winner, Westpark Elementary 4th grader, Raunak Das. The Young Masters event is part of Orange County's Imagination Celebration and is coordinated by the Assistance League of Irvine in collaboration with the IUSD Visual and Performing Arts Department and the City of Irvine. This year marks the 30th year of Young Masters. The theme this year is "Imagination Counts". The Assistance League of Irvine works closely with IUSD Art Specialists and teachers who select one piece of art from every classroom 1st – 6th Grade. This year's event had 643 pieces of art. Students are able to submit their drawing to be considered for the cover art on the event's souvenir booklet. Due to COVID-19, the Young Masters Opening Day event was canceled; however, when school opens again, photographs will be taken of each piece of art to post on the IUSD website as the 2020 virtual Young Master's Art Exhibit. 7. SUPERINTENDENT'S REPORT

Minutes:

Superintendent Walker reported on Teacher Appreciation Week, for which the Board made a video of appreciation for teachers thanking them for their hard work during this difficult time. He also thanked ITA President, Teri Sorey, for her leadership. He summarized the results of the Hanover Survey on Emergency Distance Learning, which collected feedback from parents and students. There was clear evidence that IUSD teachers are doing incredible things across the District; however, there is still some areas for growth. Nearly 8,000 parents and nearly 17,000 students in grades 3 through 12 responded to the survey. The information provided will guide discussions by administrators. One thing the Hanover Survey highlighted was the need for mental health and wellness support. While 65% of responders felt there is adequate support, we strive to do better, which is why we are announcing a new partnership with bestselling author, Shawn Achor and his team at Thought Leaders. IUSD is the first school district they have partnered with. His team will be customizing parent and student modules to optimize mental health and wellness, and increase hope and happiness. Our Administrative Advance will be focused on this work, and more information about the resource for families will be coming out soon. Regarding COVID-19, he reported, we continue to monitor the environment and are continually connecting with local and state agencies and school districts; our staff continue to leverage our resources to support our students and staff. Please visit our website iusd.org/COVID-19 for updates and information. Regarding the Credit/No Credit Grading Policy, we created a comprehensive FAQ; we welcome families to re-watch the April 14, 2020 Board Meeting where there was a thorough deliberation and consideration of the determination to adopt the Credit/No Credit policy. Other similar districts such as Palo Alto USD enacted the same policy. In closing, he welcomed continued feedback from the IUSD community and encouraged everyone to continue to review the website.
