1.0 Background and Overview

1.1 Overview

The Irvine Unified School District is comprised of a community of learners, committed to the highest quality educational experience we can envision. IUSD educates a diverse student population numbering over 30,000 (K-12), in one (1) early childhood learning center, twenty (20) elementary, two (2) K-8 schools, six (6) middle schools, four (4) comprehensive high schools, and one (1) continuation high school. The district's [strategic plan](#) is driven by our mission of enabling all students to become contributing members of society, empowered with the skills, knowledge, and values necessary to meet the challenges of a changing world.

IUSD is renowned for its nationally recognized schools, student performance well-above state and national comparisons, and comprehensive programs in academics, the arts, and athletics. The District benefits immensely from a deeply engaged and supportive community. The District is issuing this RFP to provide an engaging, web-based classroom portal to support student learning and collaboration between staff, students, and families

1.2 Requested Services

This solicitation is intended to provide a mechanism for the District to procure software and services to support course management and virtual learning environment. IUSD priorities include:

- **Course Management:** The ability for the instructor to edit or customize a course (e.g. recycle a course, automate release, reports and tracking, etc.)
- **Communication:** Provides a high level of flexibility for the use of email (asynchronous by roster, individual or group) as well as instant messaging, chat and threaded discussions.
- **Collaboration:** Provides a campus-wide framework that supports collaborative work such as wiki with version tracking, threaded discussion, instant messaging and chat, whiteboard, web conferencing (audio and video). Enables subgroups to be defined within courses for collaboration. Provides non-course sites to support special project work among small groups.
- **Content Authoring:** Provides a suite of tools for authoring media-rich content, importing content, drag-and-drop interfaces, as well as uploading rich content types such as podcasts, video clips, etc. Allows metadata creation for easier/better management.
- **Assessment Tools:** More than a simple test generator, the successful solution will provide tools for creating assessments with multimedia, learning games, and other interactive tools such as polls. Tests can provide immediate feedback with tips for remediation.
- **Support:** The company will provide implementation and ongoing support services to ensure a successful implementation and ongoing operations.
- **Design and Layout:** Simple, intuitive interface with minimal clicks to access materials, little or no training needed to get started, and the look and feel is inviting.
- **Mobile Functionality:** Offers a mobile app for use on a variety of handheld

devices. Supports all browsers and can be integrated with social media.

1.3 Current Environment

Student Information System (SIS): IUSD uses an on-premise installation of Eagle Software's Aeries Student Information System.

Course Management Solutions: Due to the decentralized nature of the district, no course management system has been mandated. The list below identifies those solutions that are in widespread use in IUSD. Other solutions may be in use by individual sites and/or teachers.

- Blackboard Learning System - Basic Edition Version 7.3.159.29 (IUSD is supporting and paying for a yearly license of Blackboard)
- Edmodo- This is a free service with the district managing passwords and teacher accounts
- My Big Campus- IUSD received My Big Campus at the beginning of the 2013-2014 school year as part of their filtering service. Select teachers have been piloting this for feedback purposes.

Authentication: Staff and Students: IUSD uses Microsoft Active Directory for authentication for all staff and students.

Staff E-mail: IUSD staff, excluding as-needed and substitute workers, use Microsoft Exchange email provided by IUSD through Office 365 for Education (Microsoft-hosted).

1.4 Period of Performance

The initial term of the contract resulting from this RFP shall be one (1) year, with four (4), one-year renewal options available to the District.

1.6 Delivery to District

A written Proposal must be received at the District Office, no later than the Proposal

Submission Deadline specified in the Calendar of Events. No telegraphic, facsimile, or emailed Proposal will be accepted. The District assumes no responsibility for late delivery.

If discrepancies between two or more copies of the Proposal are found, the Proposal may be rejected. If, however, the Proposal is not rejected, the master copy will provide the basis for resolving such discrepancies.

1.7 Withdrawal, Resubmission or Modification

A Provider may withdraw the Proposal at any time prior to the Proposal Submission Deadline specified in the Calendar of Events, by submitting a written request for its withdrawal to the Purchasing Department, signed by the Provider or authorized agent. The Provider may thereafter submit a new or modified Proposal prior to the Proposal Submission Deadline. Modification offered in any other manner, oral or written, will not be considered. A Proposal cannot be changed, corrected, or withdrawn after the Proposal Submission Deadline.

1.10 Preparation

A Proposal should be prepared in such a way as to provide a straightforward description of Provider capabilities to satisfy the requirements of this RFP. Emphasis should be concentrated on conformance to the RFP instructions, responsiveness to the RFP requirements, and on completeness and clarity of content.

The completed documents(s) should be without interlineations, alterations, or erasures. The Proposal should present all information in a concise manner, neatly arranged, legible, and in terms understandable for evaluation. All information requested is to be addressed directly and completely. It is more desirable to give additional information than less when the answer could be misinterpreted. There should be no attachments, enclosures, or exhibits other than those considered by the Provider to be essential to a complete understanding of the Proposal submitted.

1.11 False and Misleading Statements

A Proposal which contains false or misleading statements, or which provide references which do not support an attribute or condition contended by the Provider, may be rejected. If, in the opinion of the District, such information was intended to mislead the District in its evaluation

of the Proposal and the attribute, which is a condition or capability of a requirement of this RFP, the Proposal shall be rejected.

1.12 Request for Information (RFI)

Contractors are encouraged to ask questions during the open RFP period. All questions shall be in writing and submitted to the listed contact person. All responses shall be in writing by an authorized District employee or their designated representative. Questions must be received by the deadline specified in the Calendar of Events. There shall be no verbal understandings or clarifications recognized by the District. Responses to all RFIs received will be posted on the District Website.

1.13 Amendments to the RFP

During the RFP period, the District may amend the RFP. Amendments to the RFP and/or calendar of events will be posted at http://www.iusd.org/district_services/purchasing/index.html.

1.14 Limits of the RFP

IUSD reserves the right to reject all proposals and will determine what future action, if any, will be taken. All costs incurred in the preparation or submission of a proposal shall be entirely the responsibility of the Provider and shall not be chargeable directly or indirectly to the District.

2.0 Evaluation and Award

2.1 General Information

Award will be made to the Provider(s) offering the most advantageous proposal for a Course Management Solution. Irvine Unified School District shall not be obligated to accept the lowest priced proposal, but will make an award in the best interest of the District after all factors have been evaluated. The District may award the RFP to multiple providers, should the selection committee determine that different solutions best meet the needs of different sites and/or grade levels. All proposals received in response to this RFP will receive a fair and impartial evaluation by the District. In conducting this evaluation, the District may obtain and use information, in addition to that contained in the proposals, from any source desired. Customers on each Provider’s reference will be contacted, as may other customers selected by the District and listed by the Provider as a reference.

The District shall make its evaluation in its sole discretion and its decision shall be final. Public Contracts Code section 20118.2 shall govern the evaluation of proposals, selection of provider, and contract negotiations associated with this Request for Proposals

2.2 Requirements

Providers must meet all of the minimum requirements defined in this RFP, including meeting mandatory system requirements, performance expectations, and general terms. Proposals that do not meet the minimum requirements of the RFP may be, at the District’s discretion, rejected.

2.3 Scoring

Qualifying Providers will be evaluated on their complete proposal, based on the following considerations:

Interviews/Provider Presentations:

The District reserves the right to conduct in-person interview and/or require a formal presentation for all or a portion of the responding Providers.

Site Visit:

The District reserves the right to visit one or more of the Providers current customer sites.

Discussions:

Discussions may, at the District's sole option, be conducted with responsible representatives who submit proposals determined to be reasonably susceptible of being selected for an award. Discussions may be for the purpose of clarification to assure full understanding of, and responsiveness to, the solicitation requirements. Firms shall be given fair and equal treatment with respect to any opportunity for discussion and written revision of proposals. Revisions may be permitted after submissions and before award for obtaining best and final proposals. In conducting discussions, the District will not disclose information derived from proposals submitted by competing firms.

2.4 Award

The District shall post a Notice of Intent to Award on the RFP website consistent with the timeline outlined in the Calendar of Events. Any Provider protesting the award of a contract to another Provider must do so, in writing, by the deadline indicated in the Calendar of Events. The Award of the RFP will be voted on by the Board of Education at a public meeting.

2.5 Contract and Warranties

Following the Award of the RFP, the District will prepare and negotiate its own Agreement with the selected Provider(s) to deliver the proposed products and services. The resulting agreement(s) shall conform to the terms and conditions set forth in this RFP and the District's standard agreement (included in the Appendices of this document). Any exceptions or proposed alterations to conditions and requirements defined in this document and the District's standard agreement must be included in the Provider's proposal.

The Selected Provider(s) will guarantee that the Proposed Products and services shall conform in all material respects to the District's specifications in this RFP and the Selected Provider's Documentation accompanying or referred to in this RFP.

If a contract is awarded as a result of this procurement process all warranties made by the Selected Provider, including the Provider's response to the RFP, shall be incorporated into the Agreement and shall be binding upon the Selected Provider. This RFP and the Selected Provider's Proposal will become a part of the Agreement. Any Proposal attachments, documents, letters and materials submitted by the Provider shall be binding and may be included as part of the Agreement. Submission of a successful Proposal is not the end of the contractual process; further negotiation over the Agreement terms and conditions will be necessary, which, in and of itself, could change the Selected Provider.

3.0 Proposal Format

3.1 General

These instructions prescribe the mandatory Proposal format and the approach for the development and presentation of Proposal data. Proposal format instructions must be adhered to, all questions must be answered, and all requested data must be supplied. Provider response to each of the minimum requirements in this RFP is required. Failure to respond or non-adherence to any minimum requirement in this section may be cause for the Proposal to be rejected.

In addition to responding to the defined minimum requirements, IUSD encourages providers to submit information about additional functionality not specifically requested in the RFP. Providers' Proposals should be constructed to provide a complete picture of the features of the proposed solution, the firm's ability to perform, and functionality or services that may distinguish the proposed solution from other competitive offerings. Proposals will be evaluated both on the satisfaction of the District's minimum requirements, as well as the additional information submitted by providers to depict their complete solutions.

Each Provider shall submit a Proposal with all information requested. The Proposal should be as clear, complete and consistent as possible. An editable response template shall be available on the IUSD website with this RFP.

3.2 Proposal Content and Sequence

The completed Proposal must include the following items, with format and content as described.

Part 1: Vendor Support and Ability to Perform

Provide a brief description of your firm(s), as well as any other firms joining with your firm to provide services. This description should include a history of the firm(s), number of employees and organizational structure of the firm(s). This section should provide background information that supports your firm's ability to provide the requested services effectively and reliably.

In addition, provide detailed information on the proposed scope of installation services, including resources dedicated for implementation/project management, system configuration, data integration, transition from existing services, and timeline. In addition, providers should provide evidence to support the reliability of their system and the availability and expertise of support resources.

Minimum Requirements/Supporting Information:

Company Characteristics:

- P1.1** List of company contacts, with description of their roles and backgrounds that

will be assigned to IUSD's anticipated implementation and ongoing support.

- P1.2** Demonstration of a strong background in providing course management solutions for K-12 education customers. Proposal should evidence the provider's awareness of and support for the unique needs of education clients.
- P1.3** Evidence of long-term fiscal stability. Artifacts may include fiscal reports or recent audit results that demonstrate consistent and current financial security.

References:

- P1.4** Provide a minimum of five (5) references from comparable local education agencies where the Proposed Produces are in active use. Reference information must include:
 - Organization Name and Location, and Name, Title, and Contact Information of a company contact who has ongoing involvement in operations of the system and is knowledgeable about the implementation.
 - List of products and services used by the organization and the length of time those products have been in productive use. (References must be from organizations using the same or similar products and services).

Implementation:

- P1.5** Identify Provider resources/staff that will be assigned to the implementation, including estimated availability and anticipated time commitment, years of experience with the company, and recent projects similar in scope to IUSD's implementation. Describe the amount of on-site and remote time the company is expecting to devote to the implementation.
- P1.6** Draft implementation plan showing a general outline of essential tasks/milestones and the overall timeline for implementation.
- P1.7** Defined list of District and Provider responsibilities during the implementation process.

Support:

- P1.8** Provide electronic, editable copies of training materials as well as suggestions for use and best practices as part of the training process.
- P1.9** Offer unlimited 24/7/365 support through a toll-free phone number at no additional cost. Identify support structures for staff and students and families. Define whether the first point of contact for support is expected to be District or Provider staff for each audience.
- P1.10** Provide full-time, company-employed customer service professionals who are trained specifically to support the needs of K-12 public schools.
- P1.11** Require background checks for all support personnel before hiring.
- P1.12** Provide assurance that your company does not outsource customer support.

Part 2: Technical Requirements

Provide evidence to support the system's security, reliability, and interoperability. Include details about integration methodology, release schedules, service level agreements, and company development and/or security certifications.

Minimum Requirements/Supporting Information:

General:

- P2.1** The system shall be available 24/7, 365 days per year. Provide details related to scheduled maintenance windows and precautions taken to ensure high availability.
- P2.2** Describe vendor process for testing and releasing software updates, and providing for business continuity during major upgrades.
- P2.3** The system shall be designed to anticipate and provide for increases in data storage needs, increasing size and scope of data sets on-line, and increasing number of users.
- P2.4** If onsite installation, the vendor shall provide all technical documentation including minimum requirements, database sizing recommendations, and system architecture and installation.

Performance and Reliability:

- P2.5** Describe performance monitoring or other tools/techniques used to ensure consistent response times and availability of the application.
- P2.6** Describe vendor recommended/used database backup, system recovery, and failover capabilities to minimize the system downtime and risk of data loss
- P2.7** The provider must state uptime for the system for the past 3 (three) years. Uptime must include scheduled maintenance. Describe process for maintenance and uptime service level agreement.
- P2.8** Describe vendor support for disaster recovery of the complete solution in the instance of data corruption, complete data failure, complete server failure, or complete site failure. Provide evidence of comprehensive disaster recovery meeting.
- P2.9** The provider must describe any failures in the past 3 (three) years. Identify any customers that experiences lost or compromised data and the source of the issue.

Data and Interoperability

- P2.10** IUSD requires full access to extract user-generated, system and usage data. Please describe how your proposed system supports this requirement.
- P2.11** Active Directory/LDAP integration for authentication/authorization.
- P2.12** Provide a list of all Student Information Systems, Assessment, and Document Management/Collaboration Tools that your proposed solution is currently integrated with. Identify references for solutions currently in use in IUSD (Google Docs, Schoolnet, Aeries).
- P2.13** Describe your data integration and loading process, include sample file layouts.

Security:

- P2.14** The provider's information security policies are documented and available to clients upon request.
- P2.15** The provider must provide a description of their policy regarding storage, retention, and distribution of data. The provider must state the company data non-release policy.
- P2.16** The provider must allow the District to review internal and/or 3rd party audits.
- P2.17** The provider must be able to warrant that they provide background checks on all employees, and/or that only employees who have undergone said background checks will have access to client data.
- P2.18** The provider must explain internal company protocols regarding the handling of client data. The provider must require all employees to sign data handling agreements at hire.
- P2.19** The provider must certify that it employs and will continue to employ a dedicated CISSP certified security manager or the equivalent in certification to test the system and run ongoing checks/improvements.
- P2.20** The provider must be able to provide access limitations based upon district roles, and give the site system administrator a tool to modify access rights at the individual level. The provider's system must be configurable to provide specific user rights and roles and to restrict data access and administrative oversight to the appropriate personnel.
- P2.21** The system shall effectively secure and protect student information. Please describe the security measures (physical and technological) taken to protect data.
- P2.22** The vendor agrees that, even if the proposed solution is hosted by the vendor, data housed in the system remain the sole property of IUSD and cannot be used in any way not explicitly approved by the district.
- P2.23** The provider agrees that no third-party shall be given access to District data for any reason without explicit, written authorization from the District. Any third party used to support the system must be identified as a designated subcontractor in the RFP response.

Part 3: Functionality and Usability

This section should include an in-depth description of the Course Management Solution Functionality. The list below indicates minimum requirements that must be addressed by the Provider's response. However, it is essential that providers respond in a way that demonstrates the full feature set of the course management solution and its usability.

Clearly indicate in the response if the functionality is not yet available, or not fully satisfied by the current, publicly available version of the solution.

Minimum Requirements/Supporting Information:

Design and Layout:

- P3.1** Navigation and workflow is intuitive, easy to follow and efficient.

- P3.2** Courses can be customized in terms of look and feel (ie., personalized colors and themes)
- P3.3** Layout and organization of items (ie., lessons, tools, apps, etc.) can be manipulated.
- P3.4** Lessons can be presented flexibly with discussion on separate pages or embedded into lesson or group.
- P3.5** The system shall support multiple web browsers, including at least Internet Explorer, Firefox, Chrome, and Safari. Please list the browser versions supported. Please note any browser-specific limitations to the functionality provided by the system. The system shall dynamically adjust to provide the best viewing on a variety of mobile and desktop devices.

Communication:

- P3.6** Layout and organization of items (ie., lessons, tools, apps, etc.) can be manipulated.
- P3.7** Lessons can be presented flexibly with discussion on separate pages or embedded into lesson or group.
- P3.8** Provides a communication tool for direct contact to students and parents as well as other teachers.
- P3.9** Announcements can be created or course news can be delivered to multiple courses.
- P3.10** Provides an online communication and collaboration tool for live office hours where teachers can directly communicate with students at chosen times.
- P3.11** Provides a calendar that can be edited, shared among chosen groups and communities, and send automatic reminders.
- P3.12** Provides an assignment drop-box feature where teachers and students can share, upload, and download files in one clear location with connectivity to a gradebook or grading tools.
- P3.13** Provides a “Who’s Online” feature to show who is live in the group during active use.
- P3.14** Parents/families may access course assignments and announcements.
(Desirable: Parents are automatically associated with their students and have the ability to see their student’s completed work and grades).

Content Authoring:

- P3.14** Allows for creation of pages, folders, sub-folders, and links that are shareable with groups.
- P3.15** Provides embedded tools for creating multimedia materials.
- P3.16** Supports embedding external multimedia like YouTube or Vimeo into a page, lesson, or announcement.
- P3.17** Allows for the ability to share content between students and instructors with a reasonable file size allotment.

Course Management:

- P3.18** Allows the teacher to have roster management control and the ability to change student preferences.

- P3.19** Supports automated creation of rosters and/or communication of access to course sites through Student Information System.
- P3.20** Provides a grading tool where users can give feedback and share to the gradebook.
- P3.21** Provides selective and automated release of announcements, assignments, or materials chosen by the user. (Example: Assignments can be setup in advanced, and become visible to students on a pre-specified date).
- P3.22** Provides informational reports documenting student use and tracking their activity.
- P3.23** Allows for the course template to be recycled from year to year and shared between teachers and schools.
- P3.24** Provides editable notification times and type.
- P3.25** Allows for students, groups, teachers, etc. to participate in a threaded discussion forum that is saved and separate from the announcements page.

Communication:

- P3.26** Provides a platform for students to work together in real-time.
- P3.27** Provides a shareable, live whiteboard for 1:1 or 1:Group tutoring, possibly available during live office hours.

WHEREAS, DISTRICT is in need of such special services and advice; and

WHEREAS, CONSULTANT is specially trained and experienced and competent to perform the special services required by the DISTRICT, and such services are needed on a limited basis;

NOW, THEREFORE, the parties agree as follows:

1. Services to be provided by CONSULTANT:

5. Independent Contractor. CONSULTANT, in the performance of this AGREEMENT, shall be and act as an independent consultant. CONSULTANT understands and agrees that he/she and all of his/her employees shall not be considered officers, employees or agents of the DISTRICT, and are not entitled to benefits of any kind or nature normally provided employees of the DISTRICT and/or to which DISTRICT's employees are normally entitled, including, but not limited to, State Unemployment Compensation or Workers' Compensation. CONSULTANT assumes the full responsibility for the acts and/or omissions of his/her employees or agents as they relate to the services to be provided under this AGREEMENT. CONSULTANT shall assume full responsibility for payment of all federal, state and local taxes or contributions, including unemployment insurance, social security and income taxes with respect to CONSULTANT's employees.

6. Materials. CONSULTANT shall furnish, at his/her own expense, all labor, materials, equipment, supplies and other items necessary to complete the services to be provided pursuant to this AGREEMENT. CONSULTANT's services will be performed, findings obtained, reports and recommendations prepared in accordance with generally and currently accepted principles and practices of his/her profession.

7. Originality of Services. CONSULTANT agrees that all methods, writings, ideas,

technologies, formulae, procedures and/or processes prepared for, written for, submitted to the DISTRICT and/or used in connection with this AGREEMENT, shall be wholly original to CONSULTANT and shall not be copied in whole or in part from any other source, except that submitted to CONSULTANT by DISTRICT as a basis for such services.

8. Copyright/Trademark/Patent: CONSULTANT understands and agrees that all matters produced under this AGREEMENT shall become the property of DISTRICT and cannot be used without DISTRICT's express written permission. DISTRICT shall have all right, title and interest in said matters, including the right to secure and maintain the copyright, trademark and/or patent of said matter in the name of the DISTRICT.

9. Termination. DISTRICT may, at any time, with or without reason, terminate this AGREEMENT and compensate CONSULTANT only for services satisfactorily rendered to the date of termination. Written notice by DISTRICT shall be sufficient to stop further performance of services by CONSULTANT. Notice shall be deemed given when received by the CONSULTANT or no later than three days after the day of mailing, whichever is sooner.

DISTRICT may terminate this AGREEMENT upon giving of written notice of intention to terminate for cause. Cause shall include: (a) material violation of this AGREEMENT by the CONSULTANT; or (b) any act by CONSULTANT exposing the DISTRICT to liability to others for personal injury or property damage; or (c) CONSULTANT is adjudged a bankrupt, CONSULTANT makes a general assignment for the benefit of creditors or a receiver is appointed on account of CONSULTANT's insolvency. Written notice by DISTRICT shall contain the reasons for such intention to terminate and unless within ten (10) days after service of such notice the condition or violation shall cease, or satisfactory arrangements for the correction thereof be made, this AGREEMENT shall upon the expiration of the ten (10) days cease and terminate. In the event of such termination, the DISTRICT may secure the required services from another consultant. If the cost to the DISTRICT exceeds the cost of providing the service pursuant to this AGREEMENT, the excess cost shall be charges to and collected from the CONSULTANT. The foregoing provisions are in addition to and not a limitation of any other rights or remedies available to DISTRICT. Written notice by DISTRICT shall be deemed given when received by the other party, or no later than three days after the day of mailing, whichever is sooner.

10. Hold Harmless. CONSULTANT agrees to and does hereby indemnify, hold harmless and defend the DISTRICT and its governing board, officers, employees and agents from every claim or demand made and every liability, loss, damage or expense, of any nature whatsoever, which may be incurred by reason of:

a. Liability for damages for: (1) death or bodily injury to person; (2) injury to, loss or theft of property; or (3) any other loss, damage or expense arising out of (1) or (2) above, sustained by the CONSULTANT or any person, firm or corporation employed by the CONSULTANT, either directly or by independent contract, upon or in connection with the services called for in this AGREEMENT, however caused, except for liability for damages referred to above which result from the negligence or willful misconduct of the DISTRICT or its officers, employees or agents.

b. Any injury to or death of any person(s), including the DISTRICT's officers, employees and agents, or damage to or loss of any property caused by any act, neglect, default, or omission of the CONSULTANT, or any person, firm or corporation employed by the CONSULTANT, either directly or by independent contract, arising out of, or in any way connected with, the services covered by this AGREEMENT, whether said injury or damage occurs either on or off DISTRICT's property, except for liability for damages which result from

the sole negligence or willful misconduct of the DISTRICT or its officers, employees or agents.

c. Any liability for damages which may arise from the furnishing or use of any copyrighted or uncopyrighted matter or patented or unpatented invention under this AGREEMENT.

11. Insurance. Pursuant to Section 10, CONSULTANT agrees to carry comprehensive general and automobile liability insurance mutually acceptable to both parties to protect CONSULTANT and DISTRICT against liability or claims of liability which may arise out of this AGREEMENT. In addition, CONSULTANT agrees to provide an endorsement to this policy stating, "Such insurance as is afforded by this policy shall be primary, and any insurance carried by DISTRICT shall be excess and noncontributory." No later than ten (10) days from execution of this AGREEMENT by the DISTRICT and CONSULTANT, CONSULTANT shall provide DISTRICT with certificates of insurance evidencing all coverages and endorsements required hereunder including a thirty (30) day written notice of cancellation or reduction in coverage if required by the DISTRICT. CONSULTANT agrees to name DISTRICT and its governing board, officers, agents and employees as additional insureds under said policy.

12. Assignment. The obligations of the CONSULTANT pursuant to this AGREEMENT shall not be assigned by the CONSULTANT.

13. Compliance With Applicable Laws. The services completed herein must meet the approval of the DISTRICT and shall be subject to the DISTRICT's general right of inspection to secure the satisfactory completion thereof. CONSULTANT agrees to comply with all federal, state and local laws, rules, regulations and ordinances that are now or may in the future become applicable to CONSULTANT, CONSULTANT's business, equipment and personnel engaged in services covered by this AGREEMENT or accruing out of the performance of such services.

14. Confidentiality. DISTRICT shall provide CONSULTANT with access to data for the purposes of providing specific services requested by DISTRICT. CONSULTANT shall access and use the data to exclusively provide the services defined in this AGREEMENT. CONSULTANT shall maintain the confidentiality of such information. DISTRICT data remain the sole property of the DISTRICT. CONSULTANT shall not share or allow access to DISTRICT data with any third-party or sub-contractor without the prior written consent of the DISTRICT. The Parties shall each be responsible for their respective roles in managing Student Information and other data in compliance with the Family Educational Rights and Privacy Act ("FERPA") and any other applicable federal, state, and/or local statutes and legislation regarding data confidentiality and security, and any and all policies of DISTRICT relating thereto.

15. Permits/Licenses. CONSULTANT and all CONSULTANT's employees or agents shall secure and maintain in force such permits and licenses as are required by law in connection with the furnishing of services pursuant to this AGREEMENT.

16. Employment With Public Agency. CONSULTANT, if an employee of another public agency, agrees that CONSULTANT will not receive salary or remuneration, other than vacation pay, as an employee of another public agency for the actual time in which services are actually being performed pursuant to this AGREEMENT.

(c) For any county, city, city and county, municipal corporation, public DISTRICT, public agency or any political subdivision of the state, including each member of a pooling arrangement under a joint exercise of powers agreement (but not the state itself), by securing from the Director of Industrial Relations a certificate of consent to self-insure against workers' compensation claims, which certificate may be given upon furnishing proof satisfactory to the director of ability to administer workers' compensation claims properly, and to pay workers' compensation claims that may become due to its employees. On or before March 31, 1979, a political subdivision of the state which, on December 31, 1978, was uninsured for its liability to pay compensation, shall file a properly completed and executed application for a certificate of consent to self-insure against workers' compensation claims. The certificate shall be issued and be subject to the provisions of Section 3702."

I am aware of the provisions of Labor Code Section 3700 which require every employer to be insured against liability for workers' compensation or to undertake self-insurance in accordance with the provisions of that code, and I will comply with such provisions before commencing the performance of the work of this contract.

DRUG FREE WORKPLACE CERTIFICATION

This Drug-Free Workplace Certification is required pursuant to Government Code §8350, et seq., the Drug-Free Workplace Act of 1990. The Drug-Free Workplace Act of 1990 requires that every person or organization awarded a contract for the procurement of any property or services from any State agency must certify that it will provide a drug-free workplace by doing certain specified acts. NOTICE TO CONTRACTORS REGARDING CRIMINAL RECORDS CHECK

(EDUCATION CODE §45125.1)

Education Code §45125.1 provides that if the employees of any entity that has a contract with a school DISTRICT may have any contact with pupils, those employees shall submit or have submitted their fingerprints in a manner authorized by the Department of Justice together with a fee determined by the Department of Justice to be sufficient to reimburse the Department for its costs incurred in processing the application.

The Department of Justice shall ascertain whether the individual whose fingerprints were submitted to it has been arrested or convicted of any crime insofar as that fact can be ascertained from information available to the Department. When the Department of Justice ascertains that an individual whose fingerprints were submitted to it has a pending criminal proceeding for a violent felony listed in Penal Code §1192.7(c) or has been convicted of such a felony, the Department shall notify the employer designated by the individual of the criminal information pertaining to the individual. The notification shall be delivered by telephone and shall be confirmed in writing and delivered to the employer by first-class mail.

The contract shall not permit an employee to come in contact with pupils until the Department of Justice has ascertained that the employee has not been convicted of a violent or serious felony. The contractor shall certify in writing to the Board of Trustees of the school DISTRICT that none of its employees who may come in contact with pupils have been convicted of a violent or serious felony.

Penal Code §667.5(c) lists the following “violent” felonies: murder; voluntary manslaughter ; mayhem; rape; sodomy by force; oral copulation by force; lewd acts on a child under the age of 14 years; any felony punishable by death or imprisonment in the state prison for life; any felony in which the defendant inflicts great bodily injury on another; any robbery perpetrated in an inhabited dwelling; arson; penetration of a person’s genital or anal openings by foreign or unknown objects against the victim’s will; attempted murder; explosion or attempt to explode or ignite a destructive device or explosive with the intent to commit murder; kidnapping; continuous sexual abuse of a child; and carjacking.

Penal Code §1192.7 lists the following : “serious” felonies: murder; voluntary manslaughter; mayhem; rape; sodomy by force; oral copulation by force; a lewd or lascivious act on a child under the age of 14 years; any felony punishable by death or imprisonment in the state prison for life; any felony in which the defendant personally inflicts great bodily injury on another, or in which the defendant personally uses a firearm; attempted murder; assault with intent to commit rape or robbery; assault with a deadly weapon on a peace officer; assault by a life prisoner on a non-inmate; assault with a deadly weapon by an inmate; arson; exploding a destructive device with intent to injure or to murder, or explosion causing great bodily injury or mayhem; burglary of an inhabited dwelling; robbery or bank robbery; kidnapping; holding of a hostage by a person confined in a state prison; attempt to commit a felony punishable by death or imprisonment in the state prison for life; any felony in which the defendant personally uses a dangerous or deadly weapon; selling or furnishing specified controlled substances to a minor; penetration of genital or anal openings by foreign objects against the victim’s will; grand theft involving a firearm; carjacking; and a conspiracy to commit specified controlled substances offenses.
