The Irvine Unified School District is pleased to announce Series 2 of the Measure E Improvements for Northwood Elementary School. The District will be adding a new building with 3 classrooms, expansion of Food Service, relocation of the Irvine Child Care Project portables, replacement of 5 portables and removal of 3 portables at the Northwood Elementary School site, beginning in June 2020 and continuing through August of 2021. Measure E was passed by the voters within the Irvine Unified School District for providing funding for improvements at several of our existing campuses.

All interested persons are invited to attend a public meeting, which will provide information on the proposed project. IUSD representatives will be on hand to answer questions. 
