



Dear Community Member,

As previously communicated, on March 13, 2018, the IUSD Board of Education adopted a resolution to commence the process to consider establishing trustee areas for the method of electing members of the IUSD Board of Education. It is important to note, this consideration or process will have no effect on school district or student attendance boundaries. The District published three draft trustee area maps, referenced as Green, Purple and Yellow on April 17, 2018. On May 8, 2018, the IUSD Board of Education held its third public hearing on this topic and reviewed the draft maps as presented by a representative of National Demographics Corporation (NDC). The criteria adopted in drafting the maps included each proposed trustee area to span across more than one high school attendance area for varied representation, as IUSD's five membered board governs as one governance team in support of the more than 34,000 IUSD students, their families and staff. The maps presented did not meet all of the adopted criteria; therefore, the Board of Education charged NDC with adjusting the draft Purple map.

Draft trustee maps (Green, Purple, Yellow, Purple II, Purple III and Purple IV) are now available for viewing by visiting [iusd.org/BoardElectoralProcess](http://iusd.org/BoardElectoralProcess) and are on display at IUSD's Administration Office. Additionally, we have added an interactive map where residents can input their home address and can compare maps.

At the May 29, 2018 Board Meeting, the Board of Education will hold a public hearing to again, seek input regarding the content of the draft maps, which will be directly followed by a public hearing to consider adoption of a trustee area map and the by-trustee area election system commencing with the November 2018 election.
