8. SPECIAL PRESENTATIONS / RECOGNITIONS

8.a. California Dashboard Local Performance Indicators Presentation

Minutes:

Alan Schlichting, Executive Director of Student Services presented on the California Dashboard Local Performance Indicators. He explained how the District uses data from the Dashboard to support subgroups of students; staff also compare IUSD to other like districts throughout the state. The Dashboard data and other District surveys such as the BrightBytes and the Annual Survey help to provide the District with an assessment of needs or areas of focus. He reviewed the Dashboard Indicator ratings for fall 2019 and provided an overview of information available on the Dashboard. The Dashboard Indicators include information on Academic Performance, Academic Engagement, and Conditions and Climate, as well as Local Indicators with information on Implementation of Academic Standards, Access to a Broad Course of Study, Parent Involvement and Engagement, and Local Climate Survey. He reported IUSD met the requirements for all five local indicator sections. While the English Learner Progress is no longer on the Dashboard, the performance level for IUSD remains very high with 70.9% making progress towards proficiency.

Lindsay Weiss, Assessment and Evaluation Coordinator, outlined the Academic Performance for the ELA Assessment, stating the District maintained it's 65.1% points above standard. The Academic Performance indicator for Math Assessment districtwide is also in a maintained status at 57.9% points above standard. The College/Career Readiness assessment for the District declined by 2.4% from the prior year for a districtwide score of 71.5% prepared. Tammy Blakely, Student Services Coordinator, outlined the District's graduation rate as maintained status at 95.7%. Chronic absenteeism is maintained at 4.8% and the District's suspension rate is also maintained at 1%, which is two points below the state average. Alan concluded the presentation by inviting the community to visit the California School Dashboard website as it continues to be updated.

11. SUPERINTENDENT'S REPORT

Minutes:

Superintendent Walker delivered his regrets for missing the last Board Meeting due to his illness, however, he stated he did review the video from the meeting and appreciated the

comments by the Board. The California School Board Association Annual Education Conference experience and presentation was enlightening and affirming that IUSD continues to be on the cutting edge of innovation and education. He agreed with Member Glasky's recommendation that IUSD should again submit a proposal to present at the next Annual Conference, with the suggestion for the presentation to focus on mental health. He welcomed Member Carroll as President and thanked Member Brooks for serving as president last year. Additionally, he reported, Newsweek identified the top 500 STEM high schools in the country, with seven of those schools in Orange County and two of the seven being IUSD's schools. The 2018-19 California Science Test (CAST) scores are available to parents; the state will release final aggregate scores soon. This is the first year the test has been aligned to the new NGSS standards. Overall IUSD did very well. Recently, IUSD teachers came together for our Irvine Innovate Conference, where they shared best practices on a diverse range of topics and shared ideas regarding technology, mental health and wellness, engagement, automation, collaboration and assessment. In closing, he reported on attending the 21st Century Career Conference at UCI's Beckman Center, where 400 IUSD 7th grade students selected four sessions presented by industry professionals from Google, Blizzard and rocket scientists, inventors, doctors and dentists. He thanked the IUSD STEM department staff for all their efforts with the successful conference.
