#### 7. SUPERINTENDENT'S REPORT

Superintendent Walker reported that while the Governor moved many counties, including Orange County back into the purple tier a week earlier than planned, IUSD sent a communication to families that schools remain open for in-person instruction. The primary source of the surge in COVID-19 cases is from social gatherings, not schools. IUSD is now in its 8<sup>th</sup> week of in-person instruction. 17 of IUSD's 40 schools have had no cases to date. The Orange County Health Care Agency continues to be a great partner, engaging with the Orange

County Superintendents group in weekly meetings. The District is working on more readily available testing.

The District was impacted by the Silverado Fire, we are thankful for staff in their efforts to keep students safe. The Emergency Operations Center worked seamlessly. The partnership with the Irvine Policy Department and the Orange County Fire Authority was vital and well-coordinated. IUSD's new surveillance systems, on top of some of our schools, allowed for observation of the impacted area.

He extended his thanks to staff for rearranging and removing unneeded furniture to make space for adding students to the classroom. To accommodate as many students as possible, storage containers have been rented, and additional staff at the elementary and middle school levels have been hired. 81% of middle school request to switch academic models at the trimester were accommodated. In closing, he thanked Board Member Betty Carroll for her service on the Board, and sent his regards to her since she was unable to attend her last Board Meeting due to a personal emergency; however, the Facilities Study Session on December 1st will be another opportunity to wish her well before her term ends.

#### 16. ITEMS OF BUSINESS

a. Extracurricular and Cocurricular Activities Probationary Period Recommendation Approve the recommendation to provide an additional period of academic probation for all athletes and students in extracurricular and cocurricular activities.

#### Minutes:

Executive Director of Secondary Education, Keith Tuominen, presented the recommendation to extend the period of academic probation for students in extracurricular and cocurricular activities. This recommendation was derived after meeting with IUSD's high school principals who saw a need given the pandemic. The recommendation is to remove the GPA criteria; however, retaining the enrollment and passing of classes requirement. Administrators made this recommendation as an understanding that the current learning environment, since March, has been harder for some students. The last semester for the 2019-20 school year was changed to credit / no credit, which has some impact. Additionally, academic supports for students are normally provided in-person, which has been greatly limited in the current environment. It is anticipated that most students will not need this waiver, but we wish to support as many students as possible.

Member Brooks noted that this waiver of the GPA requirement for extracurricular and cocurricular activities is not just for athletics, but also for courses in drama, ASB and other after school activities

Member Glasky inquired if there was any update on the expected CIF guidance. Assistant Superintendent of Education Services, Cassie Parham, responded that it has been said that the Governor signed off on the guidance; however, since most of the state is in the purple tier, the State is delaying issuing the guidance. Furthermore, it isn't looking like the season will start in December based on current case numbers.
