#### I. First Interim Report of 2021-22 (AB 1200, Chapter 1213, Statutes of 1991)

Certify the First Interim Report of 2021-22 as "Positive" based on information presented.

#### Minutes:

John Fogarty, Assistant Superintendent of Business Services, presented the 2021-22 First Interim Report commencing with a review of the financial reporting cycle and the purpose of the Interim Report. The First Interim Report takes into consideration the fiscal outlook as

provided by the Legislative Analysts Office (LAO), which expressed remaining significant uncertainty. State revenues are higher than expected, with a significant estimated surplus in 2022-23; however, smaller general fund operating surplus in the years following. The LAO expects Proposition 98 to grow by \$11.6 billion in 2022-23, with a statutory Cost-of-Living-Adjustment (COLA) of 5.35%, in line with inflation. After factoring the cost of the COLA and other adjustments, the LAO is projecting the Legislature will have approximately \$9.5 billion in discretionary ongoing Proposition 98 funding in 2022-23, coupled with the \$11.6 billion in growth, for a total of \$20 billion.

He reviewed the ongoing challenges including the Local Control Funding Formula disproportionately benefiting districts with high concentrations of disadvantaged students, resulting in IUSD receiving \$1,808 per Average Daily Attendance (ADA) below the statewide average, in comparison to unified school districts, for an ongoing impact of \$63.4 million in less funding. Additionally, there has been a large influx of state and federal one-time funding, slowing districtwide enrollment, volatile state revenues, and ongoing pension cost increases.

IUSD received over \$61 million in one-time funding from the state and federal government related to the pandemic, requiring an exit strategy as one-time funds cannot be used to fund ongoing programs and/or costs. IUSD's enrollment trends indicate only a slight enrollment increase projected through 2022-23.

In closing, he reviewed the 2021-22 budget and multiyear projections for the unrestricted general fund which indicated a positive First Interim Report certification.
