b. Universal Pre-Kindergarten Presentation

Minutes:

Stan Machesky, Executive Director of Elementary Education, presented information regarding the Universal Pre-Kindergarten program, commencing with a brief history of Transitional Kindergarten (TK), which commenced by the passage of Senate Bill 1381 in 2010, which changed the kindergarten eligibility from students whose fifth birthday occurred before December 2nd to September 2nd. TK was phased in over three years, beginning with the 2012-13 school year. TK was defined as Kindergarten with a modified curriculum. In 2021, Assembly Bills 22 and 130 universalized access to TK for all four-year olds across the state, with a four-year phase in process and requires one teacher/adult per 12 students beginning with the 2022-23 school year. Universal Pre-Kindergarten will replace the TK program.

IUSD utilized an interdepartmental planning team with representatives from Elementary Education, Special Education, Human Resources, Fiscal Services, and multiple staff from Early Childhood Education.

Julie DeLorenzo, Coordinator for Early Learning and Primary Instruction, reviewed the four-year phase of the Universal Pre-Kindergarten program commencing in 2022-23, by offering Pre-K to students who turn 5-years old between September 2nd and February 2nd, in 2023-24 students who turn 5-years old between September 2nd and April 2nd will be eligible for Pre-K, in 2024-25 students who turn 5-years old between September 2nd and June 2nd will be eligible for Pre-K, and in 2025-26, all students who turn 4 years old on or before September 1st will be eligible for Pre-K. The eligibility information and other resources are available on the IUSD website.

The actual 2021-22 school year TK enrollment consists of 422 students, with enrollment projections for each phase of Pre-K through the 2025-26 school year projecting 1,575 Pre-K students. In order to support school districts in planning and implementation of Universal Pre-Kindergarten, the state provided a template of guiding questions to ensure consistency of program design and provided five focus areas:

Focus Area A: Vision and Coherence

Focus Area B: Community Engagement and Partnerships

Focus Area C: Workforce Recruitment and Professional Learning

Focus Area D: Curriculum, Instruction and Assessment

Focus Area E: Facilities, Services and Operations

In the area of Focus Area A: Vision and Coherence, IUSD is focused on the three years of a child's early childhood learning experience with a consistent and comprehensive program supporting the academic, developmental and social-emotional learning needs of all children. With Focus Area B: Community Engagement and Partnerships in mind, staff provided initial information about Universal Pre-Kindergarten to incoming Pre-K parents via the Parent Night in February, in addition to our Education Advisory Committee, IUCPTA, elementary and K-8 principals, all IUSD TK teachers and the Irvine Child Care Project and the City of Irvine.

Robin Hunter, the Early Childhood Learning Center (ECLC) Principal, further expanded on Focus Area B, noting staff are exploring, identifying and communicating extended day options for families.

Susan Holliday, Director of Human Resources, reviewed Focus Area C: Workforce Recruitment and Professional Learning, noting by August 1, 2023, the CDE has

required Pre-K teachers to earn 24 Early Childhood Education (ECE) units or equivalent to qualify to teach Pre-K; however, District TK teachers who taught TK prior to July 2015 are grandfathered in and are not required to earn additional units. HR held a staff informational forum in March 2022, where over 100 staff members participated. IUSD will partner with OCDE and local institutes of higher education on future recruitment and early childhood professional learning. Additionally, Pre-K teachers will have the opportunity to participate in 15 hours of Early Childhood Professional Learning created by IUSD experts.

Erin Ferguson, ECLC Coordinator, reviewed Focus Area D: Curriculum, Instruction and Assessment, noting the program will be inclusive for all learners and will cover the essential standards, assessments, developmentally appropriate practices, social and emotional learning, and use publisher materials and adoption practices. Just like primary education, the Pre-K program design will include Professional Learning Communities (PLCs), Multi-Tiered Systems and Supports (MTSS), Positive Behavior Instructional Supports (PBIS), Prevention and Intervention, and Professional Learning.

Stan outlined Focus Area E: Facilities, Services and Operations, stating that although the Pre-K enrollment is expected to be gradual, the District will face facility constraints as over 1,500 students are added. Some facilities considerations include offering Pre-K either at each neighborhood school site or within local regions, avoiding displacements of current programs or neighborhood students, providing learning and play spaces appropriate for 4-year-olds' needs, and examining of regional needs and sites that may be able to accommodate multiple Pre-K classrooms. IUSD has received \$416k to support the implementation and expansion of Universal Pre-K, these funds will support staff training, optimizing the model Pre-K learning environment and designing and selecting developmentally appropriate materials and supplies.

In conclusion, Stan shared that the District will add 10 additional teachers to the existing 15 to accommodate the additional students and to support the smaller adult to student ratio commencing with the 2022-23 school year. IUSD will maintain the current program format of Pre-K classrooms located across the City and adjust the instructional program to accommodate the developmental needs of younger learners. Currently, there are Pre-K classrooms at 23 District schools. Next steps include convening a teacher committee to design the overall program, evaluation of facility options for the 2023-24 school year, offering professional learning for Pre-K staff and continuation of fostered engagement with families.

Board members inquired into state provided facilities funding, staggered starts and acceptance of children outside the birthdate range, before and after school options for Pre-K families and suggested avoiding Pre-K and Kindergarten combo classes. Stan responded that IUSD doesn't qualify for state facilities funds for Pre-K, and that the 24 students per class is a hard cap, if space is available we want to reserve that space for families who move into the area mid-school year. Staff are in talks with ICCP regarding enrollment in their before and after school programs for Pre-K families; however, they have a different credential and license issue than school districts. There are still conversations being had. And that the District tries to avoid combo class when possible; however, the hard cap of 24 students will make that difficult.

Superintendent Walker reported on continuing to see evidence of adaptability by District staff. Related to COVID-19, cases remain relatively low; however, mitigation strategies will remain in place; many COVID-19 related investments the District made are now considered the standard across the state. The District continues to be involved in important conversations with the Orange County Health Care Agency (OCHCA); last Friday, he attended a half day meeting with the Orange County Department of Education and OCHCA regarding mental health. On that note, May is Mental Health Awareness month, please visit the IUSD website for resources. He extended is appreciation to all District staff, in honor of national Teacher Appreciation Week and the upcoming Classified Appreciation Week, and extended his thanks to the retirees for their combined 1,865 years of service. He thanked ITA and Human Resources for a wonderful Teacher of the Year celebration. The County Teacher of the Year awards also took place; where IUSD's finalist, Mickey Dickson, was honored. The Special Education department put on an Abilities Awareness event at Beacon Park; the team did a great job going above and beyond. The US News' rankings of the best high schools in the country and the state was released, IUSD is the only district with three high schools in the top 100, and four in the top 200 out of 2,400 public high schools. In closing, staff are ramping up to celebrate the District's 50th anniversary and will be sharing information about the District which will provide an opportunity for us to share some of the "whys" of our district.
