PURPOSE OF THE A-G COMPLETION IMPROVEMENT GRANT

EC 41590

Provide additional supports to LEA's to help increase the number of California high school pupils, particularly unduplicated pupils, who graduate from high school with A-G eligibility requirements completed for admission to CSU and UC schools.

ALLOCATION METHOD FOR ELIGIBLE LEAS

A-G Access Grant



LEAs that had a 2020-21 overall A-G completion rate less than 67%

A-G Success Grant



LEAs that had a 2020-21 overall A-G completion rate of 67% or higher

Learning Loss Mitigation Grant



All eligible LEAs receive these funds. Allocation based on the number of unduplicated students in grades 9-12 per 2020-21 CALPADS Fall 1

ELIGIBLE USE OF FUNDS

Access Grant

- Professional development (PD) to improve A-G completion rate.
- Developing comprehensive advising plans and other student supports, such as tutoring and college counseling services.
- Expanding access to A-G coursework, including course development and review, and incorporating courses into local graduation requirements.
- Student test fees, including AP/IB test fees, for unduplicated students.

Learning Loss Grant

- Used to allow pupils who receive a grade of "D," "F," or "Fail" in an A-G approved course in the spring semester of 2020 or 2020-21 school year to retake those A-G courses.
- LEA has flexibility in the method of offering pupils the opportunity to retake courses.
- If sufficient funds, the LEA may offer credit recovery opportunities to all pupils to ensure pupils are able to graduate high school on time.
