9. SPECIAL PRESENTATIONS / RECOGNITIONS

a. Irvine Unified Council PTA

Minutes:

Connie Stone, IUCPTA President, extended the PTA's appreciation to the Board, Superintendent Walker, and district staff for their extraordinary efforts in supporting students during the pandemic. The PTA has worked hard to adapt activities and events. She recognized the IUCPTA Executive Board volunteers for all of their hard work and dedication. She thanked the Board for the "buffet" of academic model options, which showed how the Board listened and responded to parents' needs. She also thanked the District for allowing families to switch models throughout the year based on their needs, and hope the school community remains appreciative and respectful of academic choices that are different from their own. In closing, she reported on the PTA's internal analysis on Diversity, Equity and Inclusion (DEI), by use of focus groups reviewing how people of color are experiencing the PTA. Additionally, the IUCPTA is looking into its own DEI programing to better reflect the diversity within the IUSD community.

b. Irvine Company - Excellence in Education Enrichment Fund

Jeffrey Davis, Irvine Company Vice President, presented the Irvine Company's Excellence in Education Enrichment Fund installment commencing by reminiscing about his attendance at the Board meeting, in-person, the prior year. A lot has changed since then; but rather than focus on what has changed, he reviewed the supports that have not changed, including the partnership between IUSD and the Irvine Company and the commitment and dedication by the Board, leadership and staff remains second to none. He presented a video showcase of the benefits and outcomes provided by the Irvine Company's Excellence in Education Enrichment Fund.

12. SUPERINTENDENT'S REPORT

Superintendent Walker thanked Connie Stone for her comments and extended his appreciation for providing the voice of the IUCPTA during the meeting. He extended his appreciation to the Irvine Company for their support and in helping to create programs that enrich the lives of IUSD students. He also thanked Donald Bren and Jeffrey Davis individually for their continued support. Next, he recapped some of the efforts the District has taken over the past months including accommodating more than 400 staff members, allowing families to switch academic model selections throughout the year, which many districts have not allowed. IUSD has accommodated 762 elementary families, and almost all secondary students who wanted to go to IVA. Staff were added to make those accommodations possible. At the high school level, all request to a certain point, even after extending the window, were accommodated and staff continue to look to accommodate the additional requests. The national and state guidelines from the CDC, CDPH, and OCHCA continue to affirm that schools are effectively combatting transmission of COVID-19 and the importance of schools remaining open. The Governor's Safe Schools for All Plan includes funding to open and keep schools open. There have been no cases of staff-to-student or student-to-student transmission. However, there have been a few staff-to-staff transmission cases when distancing protocols were not or could not be followed. IUSD is not the only school district to remain open, additionally, the city of Irvine's positivity numbers and case rates remain low in comparison to other cities in the county. IUSD has contracted with LivingFit Nation, as no cost COVID-19 testing option, available to staff and students. We will have testing clinics at each of our high schools starting January 25th. In closing, he reminded everyone to not get complacent with the safety measures. We are at the beginning of the end, but we need the concerted effort to continue.
