Sensitive topics will be highlighted in the presentation.
 - **MS & HS Contraception Kit** for use with **Teen Talk Lesson 5 Birth Control** was discussed and approved with a motion by Pellin Breller and seconded by Naz Hamid.
 - **HS Beyond the Binary** was discussed and not approved. The committee requested clarification as to how this material will be used.
 - **HS Creating Transgender Inclusive Schools** was discussed and not approved. The committee requested further information.
 - **HS Glossary of Gender and Transgender Terms** was discussed and not approved.
 - **HS Condom Factory Tour video** was discussed and not approved.

- **New materials for discussion** – The committee reviewed and discussed materials distributed prior to meeting.
 - Recommendations for **“A Place in The Middle”** video – discussed and not approved. The committee requested the district consider editing out the first part of the video with the history/cultural lesson and bring back to the HAC to view again for approval.
