Back when her child was attending middle school she remembers her child and herself looking at the textbook images of a family and how it was difficult to relate to the topic since the family didn't have much resemblance to their own family. Jodi expressed her child was adopted and she was a lesbian parent. It is empowering to now see diversity in the curriculum.
