Adoption of the Agenda

On the motion of Member Kuwabara, seconded by Member Parham and carried 5-0, the Board adopted the agenda as presented.

Budget Study Session

Superintendent Gross reported on the status of the State Budget, followed by a Powerpoint presentation by Assistant Superintendent Lisa Howell, who reviewed critical budget timelines, implications of filing a "qualified" 2nd Interim Report, and the current status of Proposition 98 and resulting impacts to the education budget. Projected local impacts were discussed and revised budget reduction/adjustment recommendations were presented based on the new fiscal target of \$22.5 million.

The Board discussed impacts of the District's Basic Aid funding status, including a required "fair share" contribution back to the State. Board members shared cost saving ideas and received feedback relative to viability.

Assistant Superintendent Cassie Parham provided an overview of the Tier III programs designated for flexibility and reviewed staff recommendations for reallocation of funds in the 2010-11 school year, totaling \$8.1 million.

Board members discussed program implications, facilities constraints, and impacts on individual students.

The Board expressed consensus that every facet of the organization must contribute to the solution and directed staff to leave no stone unturned in its search for revenue enhancements and expenditure reductions.
