Superintendent Gross introduced Assistant Superintendent Howell, who reviewed the revised Budget Reduction/Adjustment list, including a decrease in the fiscal target from \$22.1 million to \$20.6 million, and the addition of Art, Science and Music to the reduction options. The Board discussed various program impacts and revenue enhancement ideas and received clarification regarding estimated savings and historical program reductions.

Mark Sontag and Brad VanPatten provided potential impacts to the Science and Fine Arts Specialist programs based on the proposed reduction and responded to questions from the Board.

Board members expressed their individual preferences relative to Art, Science and Music

reductions, and weighed in on the revised staff recommendation list.

The Board reached consensus regarding the following:

- Keep reductions as equitable as possible for students and staff
- Continue to explore all revenue enhancement options
- Support for the 50/50 share concept between program reductions and employee contributions
- Bargaining units should determine how best to achieve employee contributions

The Board also expressed general agreement with the staff recommendation for reductions, and requested staff to bring back a specific proposal to reduce art, science and music to a mid-range level.

Adjourn to Closed Session

On the motion of Member Huntley-Fenner, seconded by Member Parham and carried 5-0, the Board adjourned to Closed Session at 6:32 p.m. to continue discussions regarding negotiations.
