Adoption of the Agenda

On the motion of Member McInerney, seconded by Member Wallin and carried 5-0, the Board adopted the agenda, as presented.

Facilities Master Plan Study Session

LPA representatives Jim Kisel, Kim Coffeen and Suzanne Schechtman presented an overview of the IUSD Comprehensive Facilities Master Plan including the process to date, stakeholder engagement outcomes, and review of the draft Guiding Principles and K-8 Master Program.

Advantages of flexible learning space and state of the art technology were highlighted. In addition to a summary of various committee meetings to date, stakeholder input opportunities were reviewed, including a survey of teachers, administrators and students.

Board members discussed the importance of maximum parent involvement, equity between new and older schools, and a desire to look for fiscal efficiencies based on changing learning environment needs.

Assistant Superintendent Parham reviewed each of the draft Guiding Principles, developed by the Facilities Advisory Committee:

- Respond to the needs of each student
- Promote 21st century skills
- Support professional development
- Nurture healthy people & healthy environments
- Establish the highest quality programs
- Celebrate the uniqueness of Irvine's communities
- Maintain a long-range view

Mr. Kisel presented K-8 Master Program parameters, which were developed after collecting stakeholder feedback from our K-8 schools and looking closely at innovative K-8 models across the state. Incoming Superintendent Walker suggested field trips to other districts with innovative programs.
