It is necessary to remove and replace the seven existing classroom relocatables that have reached their full lifecycle. These relocatable buildings will be replaced with an eight (8) classroom "villa" building including student and staff restrooms as well as a collaboration space in a configuration shown on Exhibit A, (reverse side of this notice).

All interested persons are invited to attend a public information meeting, which will provide information on the work proposed for the Canyon View Elementary School.
