#### **Response to Vendors' Questions**

- 1.1 Question: Can you confirm the anticipated days of service by location (Mon, Tue, Wed, Thu, Fri)?

Answer: All of the high schools are serviced every day, Monday through Friday.

- 1.2 Question: Can you share the number of individual deliveries and estimated delivery times per service day, per location?

Answer: Currently all high schools are serviced daily, with the exception of University High School which is serviced twice a day. Delivery schedules will be agreed upon by the successful bidder and individual site supervisor/designee, as specified in the General Conditions, Number 12, Deliveries.

- 1.3 Question: Can you let us know what the delivery time requirements are for each school?

Answer: Delivery schedules will be agreed upon by the successful bidder and individual site supervisor/designee, as specified in the General Conditions, Number 12, Deliveries.

- 1.4 Question: Can you confirm that this bid is only for the 5 high schools?

Answer: Yes, this RFP only services the high schools listed in the General Conditions on page 47. However, the Irvine Unified School District is a growing district, therefore, the District reserves the right to add or delete locations at its discretion at any time throughout the term of this proposal, as specified in the General Conditions, Number 1, Add/Delete Locations.

- 1.5 Question: On page 5 under proposal deadline, what is the Food Transport Unit?

Answer: A carrier, such as a hot bag/box, that the food will stay at the specified temperature.



1.6 Question: There are three “formats” described in the RFP. Could you please clarify how often and what volume you will require by format?

16” 8 Slice Whole pizza

16” 8 Slice Whole Pizza with Individually Boxed Slices

Individual Pizzas Cut into 4 Slices

Answer: The high schools are serviced daily. For volumes see ‘Estimated Annual Usage’ in the Proposal Form Pricing Sheet on page 22.

1.7 Question: Will all three formats be required at any given school?

Answer: We anticipate that the 16” 8 slice whole pizzas will be required at each high school. However, we do not anticipate requiring both the individually boxed slices and the individual pizzas at each high school.

1.8 Question: Will you consider accepting the individual pizzas whole/not cut?

Answer: No, we cannot accept *uncut* individual pizzas.

1.9 Question: Will you consider serving, in addition to the 16 inch whole pizzas, either individually boxed slices or individual pizzas, not both?

Answer: Yes, we will consider it.

1.10 Question: Will you consider 6” individual pizza uncut to be the sole product utilized at each school?

Answer: We will consider individual *cut* pizzas as the sole product but we cannot accept *uncut* individual pizzas.
