 Only two voting members were in attendance. A quorum was not established. Meeting continued as an open forum.

Reading of last Minutes (Secretary)

Dir. Hertig reviewed what CAC does with the school district's SELPA.

The CAC invites members of the public to present information to the Committee and District about topics of interest or concern to individuals. That information is then taken into consideration for programming, funding and future event planning, including but not limited to clubs, parent trainings and specialized programing.

Dir. Hertig Reviewed Funding sources.

IDEA (Federal Law) only funds 10% not the 40% promised. State provides 35% more, for each student regardless of disability or not. The remaining 55% is the school district funded.

Dir. Hertig reviewed the Bylaws.

Families Concerns:

- No information from schools on programs available or what to ask for during an IEP meeting.
- School Psychologists are the case managers but do not seem to have the awareness of how to run an IEP meeting that is welcoming and open. Not enough training to staff on how to run an IEP meeting.
- High turn over in some schools with new teachers and staff not invested in their child.

Parent shared that the National Down Syndrome Conference was amazing and not to miss. http://www.dsfoc.org/

Parent expressed need to get more community between families. Often our children go to school and we don't see the parents. More social event planning is needed.

Discussion on IPSF- Irvine Public School Foundation

- A non profit organization that is not part of IUSD. It is a separate entity that funds IUSD programs.
- Summer programming- want sped specific classes offered.

- Summer programming allowed to bring private shadow that is not a parent. Must have Livescan fingerprinting and form is available through IPSF. Must clear prior to entering school. Must connect with principal on-site.
- Danielle to connect with IPSF to see about funding and an account to be set up for fundraising.

Open Discussion about difficulties in IEPs and whom to contact what to do when that does not work.

- First contact your program specialist. The contact form was provided at the meeting.
- Danielle reminded parents to get acquainted with classroom policies, school-based policies, and school District policies. Get them in writing and make sure that the policies do not conflict with the IEP or their child's instructional needs.
